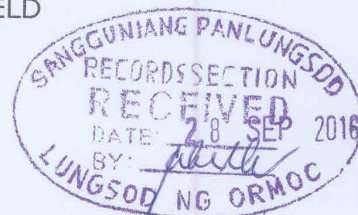

PREFATORY STATEMENT

WHEREAS, presented to this august Body for consideration is a letter dated September 2, 2016 from the Office of the City Mayor, urgently requesting for a supplemental budget in the amount of FOURTEEN MILLION PESOS (P14,000,000.00) for the Construction/Improvement of Tourism Facilities – Civil Works and Supply and Installation of Multi-Pattern Modular Fountains at the City Public Plaza;

WHEREAS, the requested supplemental budget is intended to carry out one of the priority projects of City Mayor Richard I. Gomez as part of the Tourism Development of the City which comprises the installation of Three Multi-Pattern Modular Fountains, two (2) of which are to be installed in front of the Old City Hall Building and the other one (1) will be in front of Don Felipe Hotel thus, the need to be funded as it is deemed essential for the development /Improvement of the Ormoc City Public Plaza for aesthetic reasons;

WHEREAS, through a certification dated September 7, 2016, the City Budget Officer, the City Treasurer, and the City Accountant, certified that the amount of FOURTEEN MILLION PESOS (P14,000,000.00) which may be taken from the Unappropriated Surplus, end of the year 2015, is deemed available for Construction/Improvement of Tourism Facilities – Civil Works and Supply and Installation of Multi Pattern Modular Fountains at the Ormoc City Public Plaza;

*AN ORDINANCE APPROPRIATING THE AMOUNT OF
FOURTEEN MILLION PESOS (P14,000,000.00) TO BE
TAKEN FROM THE UNAPPROPRIATED SURPLUS, END OF
THE YEAR 2015, FOR THE
CONSTRUCTION/IMPROVEMENT OF TOURISM
FACILITIES - CIVIL WORKS AND SUPPLY AND
INSTALLATION OF MULTI -PATTERN MODULAR
FOUNTAINS AT THE ORMOC CITY PUBLIC PLAZA.*

BE IT ENACTED, by the Fourteenth Sangguniang Panlungsod ng Ormoc,
That:

SECTION 1. 2016 GENERAL FUND SUPPLEMENTAL BUDGET. The sum of
FOURTEEN MILLION PESOS (P14,000,000.00) of the General Fund Supplemental
Budget of Ormoc City is hereby appropriated for the Construction/Improvement of
Tourism Facilities, specifically for Civil Works and Supply and Installation of Multi-
Pattern Modular Fountains to be taken the Unappropriated Surplus, end of year
2015.

SECTION 2. EFFECTIVITY. This Appropriation Ordinance shall take effect
immediately upon its approval subject however, to the compliance of the posting
and publication requirements as provided in the Local Government Code of 1991.

RESOLVED, FURTHER, that sufficient copies of this Appropriation Ordinance
together with all supporting documents be submitted to the Honorable Secretary,
Department of Budget & Management, Manila, through the City Budget Officer of
Ormoc and the Regional Director, Department of Budget & Management, Tacloban
City, for review purposes;


ENACTED, September 14, 2016.

of the Session Hall during the voting.




