PREFATORY STATEMENT

WHEREAS, presented to this august Body for consideration is an Indorsement dated September 14, 2016 from the Office of the City Mayor, relative to the preceding Indorsement of the City Agriculturist, Dr. Joseph C. Cortes, requesting for a supplemental budget in the amount of TWO HUNDRED THOUSAND (P200,000.00) PESOS ONLY as LGU-Ormoc's Cash Counterpart for the small livelihood project entitled "Vegetable Production Livelihood Project of Ormoc Vegetables Farmers Association (OVFA)";

WHEREAS, the Vegetable Production Livelihood Project of OVFA is under the Investment for Rural Enterprises for Agriculture & Fisheries Program (IREAP) sub project of the Philippines Rural Development Program (PRDP);

WHEREAS, the proposed livelihood project is in line with DA-PRDP RPCO 8, Regional Project Advisory Board Resolution No. 21 in its purpose to carry out and finance the sub-projects proposed by LGU's under the Infrastructure and Enterprise Development Components of PRDP which aim is to rehabilitate the main livelihood of the target beneficiaries and assist them in increasing their production to improve their socio-economic capacity thus, the need to be funded in order to achieve such intention;

WHEREAS, the City Budget Officer, the City Treasurer, and the City Accountant, through a certification dated September 16, 2016, certified that the amount of TWO HUNDRED THOUSAND (P200,000.00) PESOS ONLY is deemed available, to be taken from the Unappropriated Surplus, end of year 2015, as LGU-Ormoc's counterpart fund for the Small Livelihood Project - Vegetable Production Livelihood Project of Ormoc Vegetables Farmers Association (OVFA) under the investments for Rural Enterprises for Agricultural & Fisheries Productivity (I-REAP);

FOREGOING PREMISES CONSIDERED, on motion of SP Member Mario M. Rodriguez, Chairman, Committee on Finance and Appropriation, severally seconded by SP Members Vincent L. Rama, Rolando M. RESOLVED, to enact:

APPROPRIATION ORDINANCE NO. 2016-007
(General Fund)

AN ORDINANCE APPROPRIATING THE AMOUNT OF TWO HUNDRED THOUSAND (P200,000.00) PESOS AS LGU-ORMOC CASH COUNTERPART FOR THE VEGETABLE PRODUCTION LIVELIHOOD PROJECT OF ORMOC VEGETABLES FARMERS ASSOCIATION (OVFA) UNDER THE INVESTMENTS FOR RURAL ENTERPRISES FOR AGRICULTURAL & FISHERIES PRODUCTIVITY (I-REAP), TO BE TAKEN FROM THE UNAPPROPRIATED SURPLUS, END OF THE YEAR 2015.

BE IT ENACTED, by the Fourteenth Sangguniang Panlungsod ng Ormoc, That:

SECTION 1. 2016 GENERAL FUND SUPPLEMENTAL BUDGET. The sum of TWO HUNDRED THOUSAND (P200,000.00) PESOS, of the General Fund Supplemental Budget of Ormoc City is hereby appropriated as LGU-Ormoc Cash Counterpart fund for the Vegetable Production Livelihood Project of Ormoc Vegetables Farmers Association (OVFA).

SECTION 2. EFFECTIVITY. This Appropriation Ordinance shall take effect immediately upon its approval subject however, to the compliance of the posting and publication requirements as provided in the Local Government Code of 1991.

RESOLVED, FURTHER, that sufficient copies of this Appropriation Ordinance together with all supporting documents be submitted to the Honorable Secretary, Department of Budget & Management, Manila, through the City Budget Officer of Ormoc and the Regional Director, Department of Budget & Management, Tacloban City, for review purposes;


ENACTED, October 13, 2016.

RESOLVED, FURTHERMORE, to furnish copies of this Appropriation Ordinance one each to City Mayor Richard I. Gomez; the OIC-City Administrator, Mr. Vincent L. Emnas; the Acting-City Legal Officer, Atty. Marcelo C. Oñate; the City Treasurer; the City Budget Officer; the City Accountant; the City Auditor; the OIC-City Director, DILG, Engr. Jesus Jeremy D. Bagares; the City Agriculture Office; the OVFA; and other offices concerned;


