PREFATORY STATEMENT

WHEREAS, presented to the Fourteenth Sangguniang Panlungsod ng Ormoc for consideration is an Urgent Indorsement dated October 4, 2016 from the City Mayor Richard I. Gomez pertaining to the letter request of the OIC-City Administrator, Mr. Vincent L. Emnas, for reversion of the account- Capital Outlay-Office Equipment for CYs 2015 and 2016 in the total amount of ONE HUNDRED FORTY THOUSAND PESOS (P140,000.00) to fund the purchase of Two (2) units Air Ozonator for the City Administrator's Office;

WHEREAS, Air Ozonators have potentials in controlling indoor air pollution thus, its installation in the City Administrator's Office is deemed necessary due to high probability of air contamination in its office premises considering the volume of documents and varied government transactions passing through and dealt with by the same office;

The subject request was referred to the Offices of the City Budget Officer, City Treasurer and City Accountant for identification as to the appropriate source of funds, and in effect, a certification from the concerned offices was issued dated September 30, 2016 stating therein that the amount of ONE HUNDRED FORTY THOUSAND PESOS (P140,000.00) to fund the proposed purchase of air ozonators under the account -Other Property, Plant & Equipment is deemed available to be taken from out of the reversion of CYs 2015 & 2016 appropriations of the account-Office Equipment;

SECTION 1. 2016 GENERAL FUND SUPPLEMENTAL BUDGET. The sum of ONE HUNDRED FORTY THOUSAND PESOS (P140,000.00) of the General Fund Supplemental Budget of Ormoc City is hereby reverted and appropriated for the purchase of Two(2) Units Air Ozonator under the account- Other Property, Plant and Equipment to be taken from out of reversion of the CYs 2015 & 2016 Appropriations of the account – Office Equipment.

SECTION 2. EFFECTIVITY. This Appropriation Ordinance shall take effect immediately upon its approval.

RESOLVED, FURTHER, that sufficient copies of this Appropriation Ordinance, together with all supporting documents thereof, be submitted to the Honorable Secretary of Department of Budget and Management, Manila, through the City Budget Officer of Ormoc, and the Regional Director, Department of Budget & Management, Tacloban City, for review purposes;


