PREFATORY STATEMENT

WHEREAS, presented to the Fourteenth Sangguniang Panlungsod ng Ormoc for consideration is an Orgent Indorsement dated October 4, 2016 from the City Mayor Richard A Gomez relative to the letter request of Dr. Joseph C. Cortes, City Agriculturist, for a supplemental appropriation in the amount of SEVEN HUNDRED THOUSAND PESOS (2700,000.00) to fund the project titled : REPAIR/REHABILITATION/ RESTORATION OF SORTING/ STORAGE/POST HARVEST FACILINES FOR FRESH VEGETABLES IN BARANGAY CABINTAN, ORMOC CITY;

WHEREAS, the existing Post Harvest Facilities in Barangay Cabintan was among those government structures heavily damaged by Typhoon Yolanda and now calls for immediate repairs and rehabilitation;

WHEREAS, the prompt implementation of the sought facilities' repairs and rehabilitation will aid the farmer-beneficiaries in maintaining the high quality of our local vegetable products which are marketed not just in our city but also contracted out to high-end companies in other cities thereby will translate to higher income and profitability of our farmers;

WHEREAS, further, the continued operation of the subject facilities after its repairs is in line with the priorities of the present administration to develop the agriculture sector by among others, creating a stronger marketing support program for agriculture products and working for stronger linkage between market and production;

WHEREAS, the request was referred to the Offices of the City Budget Officer, City Treasurer and City Accountant for identification as to the appropriate source of funds, and in response a certification from the concerned offices was issued dated September 30, 2016 stating therein that the amount of SEVEN HUNDRED THOUSAND PESOS (P700,000.00) to fund the proposed Project titled: REPAIR/REHABILITATION/ RESTORATION OF SORTING/ STORAGE/POST HARVEST FACILITIES FOR FRESH VEGETABLES IN BARANGAY CABINTAN, ORMOC CITY is deemed available to be taken from the Unappropriated Surplus, end of year 2015 of the General Fund;

FOREGOING PREMISES CONSIDERED, on motion presented by SP Member Mario M. Rodriquez, Chairman, Committee on Finance and Appropriation, severally seconded by SP Members Vincent L. Rama, Tomas R. RESOLVED, to enact:

APPROPRIATION ORDINANCE NO. 2016-010 (General Fund)

AN ORDINANCE APPROPRIATING THE AMOUNT OF SEVEN HUNDRED THOUSAND PESOS (P700,000.00) IMPLEMENTATION OF THE PROJECT TITLED: REPAIR/ REHABILITATION/ RESTORATION SORTING/ STORAGE/POST HARVEST FACILITIES FOR FRESH VEGETABLES IN BARANGAY CABINTAN, ORMOG CITY TO BE TAKEN FROM THE UNAPPROPRIATED SUMPLUS, END OF YEAR 2015 OF THE GENERAL FUND.

BE IT ENACTED, by the Fourteenth Sangguniang Panlungsod ng Ormoc, That:

SECTION 1, 2016 GENERAL FUND SUPPLEMENTAL BUDGET. The sum of SEVEN JUNDRED THOUSAND PESOS (P700,000.00) of the General Fund Supplemental Budget of Ormoc City is hereby appropriated for the Repair/Rehabilitation Restoration of the Sorting/ Storage/ Post Harvest Facilities for Fresh Vegatables in Barangay Cabintan, Ormoc City to be taken from the Unappropriated Surplus, End of Year 2015.

SECTION 2. <u>EFFECTIVITY.</u> This Appropriation Ordinance shall take effect immediately upon its approval.

RESOLVED, FURTHER, that sufficient copies of this Appropriation Ordinance, together with all supporting documents thereof, be submitted to the Honorable Secretary of Department of Budget and Management, Manila, through the City Budget Officer of Ormoc, and the Regional Director, Department of Budget & Management, Tacloban City, for review purposes;

ENACTED, October 19, 2016.

RESOLVED, FURTHERMORE, to furnish copies of this Appropriation Ordinance, one each to the City Mayor Richard I. Gomez; the OIC- City Administrator, Mr. Vincent L. Emnas; the Acting City Legal Officer, Atty. Marcelo C. Oñate; the City Budget Officer; the City Accountant; the City Treasurer; the City Auditor; the City Agriculture Office; the OIC-City Director, DILG, Engr. Jeremy D. Bagares; and other offices concerned;
