# PREFATORY STATEMENT

WHEREAS, presented to this august Body for consideration is an Urgent Indorsement dated October 7, 2016 from the City Mayor Richard I. Gomez in connection with the Three (3) separate letter-requests of Engr. Domardoni C. Cayanong, City General Services Officer, for supplemental appropriation in the total amount of EIGNTEEN MILLION SEVEN HUNDRED SIXTY-FIVE THOUSAND PESOS (P18.765,000.00) for the following objects of expenditure of the City General Services Office (CG50), to wit:

1. Brand New Truck Mounted Crane Triple Extension

Complete with accessories

- P 9,015,000.00 - 7,150,000.00

2. Purchase of Brand New Aerial Platform

Purchase of Two(2) Units Brand New Service Vehicles

- 2,600,000.00

TOTAL

-P18,765,000.00

WHEREAS, to recall, the 3<sup>rd</sup> request which was the purchase of Two (2) units Brand New Service Vehicles amounting to P2,600,000.00 was already acted upon and earlier approved under Appropriation Ordinance No. 2016-011 and only the first two (2) requests pertaining to the purchases of Brand New Truck Mounted Crane Triple Extension complete with accessories in the amount of P9,015,000.00, and that of Brand New Aerial Platform costing P7,150,000.00, were left out due to some concerns raised by the members of the committee for the need of conducting further research by the requisitioning Office for better alternative units of heavy equipment which specifications corresponds to or equivalent to the given specifications and yet deemed more practical for the city in terms of cost and service efficiency;

WHEREAS, the City General Services officer, upon further research was able to present alternative units of the proposed original heavy equipment to be procured as presented earlier, which specifications correspond to the needs of the city, and the Body was convinced that the newly presented alternative heavy equipment units are indeed more advantageous for the city to acquire in terms of cost and service efficiency, hence, the matter needs to be acted upon favorably in order to address the urgent need for the purchase of the above requested heavy equipment for efficient and speedy implementation of the different programs and projects of the City General Services Office;

WHEREAS, with respect to the funding requirements thereof, the Offices of the City Budget Officer, City Treasurer and City Accountant issued certification dated October 6, 2016 certifying therein that the amount needed to fund the proposed purchase of One(1) Unit Brand New Aerial Platform costing P7,150,000.00 and One (1) Unit Brand New Truck Mounted Crane Triple Extension complete with accessories in the amount of P9,015,000.00 both under the account Capital Outlay-Construction and Heavy Equipment, for a total of SIXTEEN MILLION ONE HUNDRED SIXTY FIVE THOUSAND PESOS (P16,165,000.00) is available to be taken from the Unappropriated Surplus, End of Year 2015 of the General Fund;

AN ORDINANCE APPROPRIATING THE AMOUNT OF SIXTEEN MILLION ONE HUNDRED SIXTY FIVE THOUSAND PESOS (P16,165,000.00) TO BE TAKEN FROM THE UNAPPROPRIATED SURPLUS, END OF YEAR 2015 OF THE GENERAL FUND FOR THE PURCHASE OF THE FOLLOWING HEAVY EQUIPMENT FOR THE CITY GENERAL SERVICES OFFICE USE, TO WIT:

1 ONE (1) UNIT BRAND NEW TRUCK MOUNTED CRANE TRIPLE EXTENSION COMPLETE WITH ACCESSORIES - P9,015,000.00

2. ONE (1) UNIT BRAND NEW

AERIAL PLATFORM

- 7,150,000.00

BE IT ENACTED, by the Fourteenth Sangguniang Panlungsod ng Ormoc, That:

SECTION 1. 2016 GENERAL FUND SUPPLEMENTAL BUDGET. The sum of SIXTEEN MILLION ONE HUNDRED SIXTY FIVE THOUSAND PESOS (P16, 165,000.00) of the General Fund Supplemental Budget of Ormoc City is hereby appropriated for the purchase of the aforementioned heavy equipment for the City General Services Office use to be taken from the Unappropriated Surplus, End of Year 2015 of the General Fund.

SECTION 2. <u>EFFECTIVITY.</u> This Appropriation Ordinance shall take effect immediately upon its approval.

RESOLVED, FURTHER, that sufficient copies of this Appropriation Ordinance, together with all supporting documents thereof, be submitted to the Honorable Secretary of Department of Budget and Management, Manila, through the City Budget Officer of Ormoc, and the Regional Director, Department of Budget & Management, Tacloban City, for review purposes;
