PREFATORY STATEMENT

WHEREAS, presented to this Sanggunian for consideration is an Urgent Indorsement dated October 21, 2016 from the City Mayor Richard I. Gomez, requesting for a supplemental appropriation in the amount of SEVEN MILLION ONE HUNDRED SEVENTY NINE THOUSAND NINE HUNDRED SIXTY PESOS (P7,179,960.00) to be taken from the Unappropriated Surplus, End of year 2015 of the General Fund for the following Capital Outlay accounts of the City Mayor's Office, to wit:

Communication Equipment	51,960.00

WHEREAS, the supplemental appropriation requested for motor vehicles is intended to purchase Four (4) units brand new pick-up vehicles with ambush type swat van for the Ormoc-PNP which is of great assistance to our PNP personnel to enable them to respond immediately to emergencies and allow them to be in situations where armed confrontation is likely, as well as for transportation in the conduct of police patrols, all these are aimed at providing quality services to Ormocanons.

WHEREAS, the appropriation for communication equipment will be used to purchase Four (4) Mobile Phones for the Media Center use to enhance the communication system of the Media Center personnel;

WHEREAS, the City Budget Officer, the City Treasurer, and the City Accountant, through a certification dated October 24, 2016, certified that the amount of SEVEN MILLION ONE HUNDRED SEVENTY NINE THOUSAND NINE HUNDRED SIXTY PESOS (P7,179,960.00) is deemed available to be taken from the Unappropriated Surplus, End of year 2015 of the General Fund and may be utilized to supplement the Capital Outlay accounts of the City Mayor's office (CMO) to wit:

AN ORDINANCE APPROPRIATING THE AMOUNT OF SEVEN MILLION ONE HUNDRED SEVENTY NINE THOUSAND NINE HUNDRED SIXTY PESOS (P7,179,960.00) TO BE TAKEN FROM THE UNAPPROPRIATED SURPLUS, END OF YEAR 2015 OF THE GENERAL FUND FOR THE FOLLOWING CAPITAL OUTLAY ACCOUNTS OF THE CITY MAYOR'S OFFICE, TO WIT:

BE IT ENACTED, by the Fourteenth Sangguniang Panlungsod ng Ormoc, That:

SECTION 1. 2016 GENERAL FUND SUPPLEMENTAL BUDGET. The sum of SEVEN MILLION ONE HUNDRED SEVENTY NINE THOUSAND NINE HUNDRED SIXTY PESOS (P7,179,960.00) of the General Fund Supplemental Budget of Ormoc City is hereby appropriated to supplement the Capital Outlay accounts – Motor Vehicles and Communication Equipment of the City Mayor's Office to the taken from the Unappropriated Surplus, end of Year 2015.

SECTION 2. EFFECTIVITY. This Appropriation Ordinance shall take effect immediately upon its approval subject however, to the compliance of the posting and publication requirements as provided in the Local Government Code of 1991.


