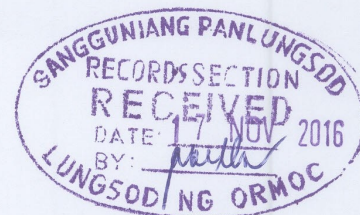

PREFATORY STATEMENT

WHEREAS, presented to this august Body for consideration is an Urgent Indorsement dated October 28, 2016 from the City Mayor Richard I. Gomez relative to the request of the OIC- Public Market Administrator, Arthur C. Arcuino, for a supplemental budget amounting to FIVE MILLION FOUR HUNDRED THOUSAND PESOS (P5,400,000.00) for the following projects, to wit:

WHEREAS, the implementation of the aforementioned projects as the objects of the requested supplemental budget are for purposes of, firstly, constructing the necessary amenity in line with the plan of the City Mayor to transfer the local fish wholesalers (Alpur) to the Bagsakan Area in Brgy. Alegria, hence, the need to provide wastewater treatment facility to maintain sanitation in the area, and secondly, to provide additional toilet facilities with provision for PWDs within the premises of the Ormoc City Food Park in response to the need of the growing number of public consumers patronizing the said establishment, all of these are directed to promote and maintain cleanliness and sanitation in the city;

WHEREAS, the City Budget Officer, City Treasurer and City Accountant, through a certification dated October 25, 2016 certified that the amount above requested for the implementation of the aforementioned projects totaling to FIVE MILLION FOUR HUNDRED THOUSAND PESOS (P5,400,000.00) is available to be taken from the Unappropriated Surplus, End of Year 2015 of the Market Office;

BE IT ENACTED, by the Fourteenth Sangguniang Panlungsod ng Ormoc, That:

SECTION 1. 2016 GENERAL FUND SUPPLEMENTAL BUDGET. The sum of FIVE MILLION FOUR HUNDRED THOUSAND PESOS (P5,400,000.00) of the General Fund Supplemental Budget of Ormoc City is hereby appropriated for the implementation of the aforementioned projects of the Market Office to be taken from the Unappropriated Surplus, End of Year 2015 of same office.

SECTION 2. EFFECTIVITY. This Appropriation Ordinance shall take effect immediately upon its approval.

RESOLVED, FURTHER, that sufficient copies of this Appropriation Ordinance, together with all supporting documents thereof, be submitted to the Honorable Secretary of Department of Budget and Management, Manila, through the City Budget Officer of Ormoc, and the Regional Director, Department of Budget & Management, Tacloban City, for review purposes;


