PREFATORY STATEMENT

WHEREAS, presented to this Sanggunian for consideration is an Indorsement dated October 28, 2015 from the Office of the City Mayor, pertaining to the request of Dr. Nelita D. Navales, City Health Officer II, for a supplemental budget in the amount of SIX MILLION FIVE HUNDRED THOUSAND PESOS (P6,500,000.00) for the purchase of Five (5) units Brand New Vehicles for the Five (5) District Health Centers, namely: Curva, Ipil, Valencia, Doña Feliza Mejia and Linao;

WHEREAS, the requested supplemental appropriation covering the matter is deemed essential for the City Health Office to carry out its mission of providing health care services to the people of Ormoc;

WHEREAS, in order to carry out this mission, the City Health Office intends to purchase Brand New Motor Vehicles as replacement of their existing service vehicles which often break down due to wear and tear after having been used for more than ten (10) years, thus, the need for the acquisition of new service vehicle units to achieve a fast and continued delivery of its health services towards the constituents of Ormoc;

WHEREAS, through a certification dated October 26, 2016, the City Budget Officer, the City Accountant, and the City Treasurer, certified that the amount of SIX MILLION FIVE HUNDRED THOUSAND PESOS (P6,500,000.00) is deemed available to be taken from the Unappropriated Surplus, end of year 2015, of the General Fund to purchase Five (5) units Brand New Motor Vehicles for the Five (5) District Health Centers of the City Health Office;

APPROPRIATION ORDINANCE NO. 2016-016 (General Fund)

AN ORDINANCE APPROPRIATING THE AMOUNT OF SIX MILLION FIVE HUNDRED THOUSAND PESOS (P6,500,000.00) TO BE TAKEN FROM THE UNAPPRORIATED SURPLUS, END OF YEAR 2015, OF THE GENERAL FUND TO PURCHASE FIVE (5) UNITS BRAND NEW MOTOR VEHICLES FOR THE FIVE (5) DISTRICT HEALTH CENTERS OF THE ORMOC CITY HEALTH OFFICE.

BE IT ENACTED, by the Fourteenth Sangguniang Panlungsod ng Ormoc, That:

SECTION 1. 2016 GENERAL FUND SUPPLEMENTAL BUDGET. The sum of SIX MILLION FIVE HUNDRED THOUSAND PESOS (P6,500,000.00) of the General Fund Supplemental Budget of Ormoc City is hereby appropriated for the purchase of Five (5) units Brand New Motor Vehicles for the City Health Office' Five (5) District Health Centers to be taken the Unappropriated Surplus, end of year 2015 of the General Fund.

SECTION 2 EFFECTIVITY. This Appropriation Ordinance shall take effect immediately upon its approval subject however, to the compliance of the posting and publication requirements as provided in the Local Government Code of 1991.

RESOLVED, FURTHER, that sufficient copies of this Appropriation Ordinance together with all supporting documents be submitted to the Honorable Secretary, Department of Budget & Management, Manila, through the City Budget Officer of Ormoc and the Regional Director, Department of Budget & Management, Tacloban City, for review purposes;
