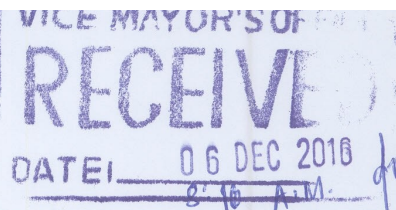
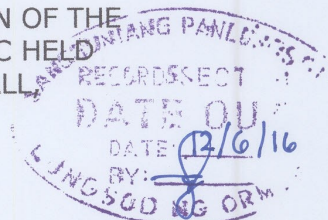

PREFATORY STATEMENT

WHEREAS, presented to this august Body for consideration is an Indorsement dated November 7, 2016 from the Office of the City Mayor relative to the request of Mr. Vincent L. Emnas, OIC Head - Office of the Senior Citizens Affairs (OSCA), for a supplemental appropriation amounting to SIX MILLION THREE HUNDRED FIFTY FIVE THOUSAND AND FIVE HUNDRED PESOS (P6,355,500.00) to fund the Birthday Gifts of the 4,237 Ormoc City Senior Citizens celebrants for the months of October, November, and December 2016 respectively, as per Ordinance No. 184 dated June 20, 2013, entitled: " AN ORDINANCE GRANTING A BIRTHDAY GIFT TO BONA FIDE SENIOR CITIZEN RESIDENTS OF ORMOC CITY AND APPROPRIATING FUNDS" as amended;

WHEREAS, the city's Annual Budget for CY 2016 has an appropriation of Fifteen Million Pesos (P15,000,000.00) for the implementation of the Birthday Gift program of the Office of the Senior Citizens Affairs (OSCA);

WHEREAS, due to the increasing number of members of the Senior Citizens in the city, the appropriated amount for CY 2016 was depleted hence, the need to be supplemented to cover the said matter in order for the remaining senior citizens' birthday celebrants for the current year to receive such benefit;

WHEREAS, through a certification dated November 9, 2016, the City Budget Officer, the City Treasurer, and the City Accountant, certified that the amount of SIX MILLION THREE HUNDRED FIFTY FIVE THOUSAND AND FIVE HUNDRED PESOS (P6,355,500.00) intended to augment the appropriation for Birthday Gift for the months of October-December, 2016 under the account - Donations - is deemed available to be taken from the Unappropriated Surplus, end of year 2015 of the General Fund;

FOREGOING PREMISES CONSIDERED, on motion of SP Member Mario M. Rodriguez, Chairman, Committee on Finance and Appropriation, severally seconded by SP Members Vincent L. Rama, Tomas R. Serafica, John Eulalio Nepomuceno O. Aparis II and Mariano Y. Corro; be it

RESOLVED, to enact:

*APPROPRIATION ORDINANCE NO. 2016-017
(General Fund)*

AN ORDINANCE APPROPRIATING THE AMOUNT OF SIX MILLION THREE HUNDRED FIFTY FIVE THOUSAND AND FIVE HUNDRED PESOS (P6,355,500.00) TO BE TAKEN FROM THE UNAPPROPRIATED SURPLUS, END OF YEAR 2015, TO SUPPLEMENT THE ACCOUNT – DONATIONS – OF THE OFFICE OF THE SENIOR CITIZENS AFFAIRS (OSCA), FOR THE PAYMENT OF SENIOR CITIZENS' BIRTHDAY GIFT FOR THE MONTHS OF OCTOBER, 2016 TO DECEMBER, 2016.

BE IT ENACTED, by the Fourteenth Sangguniang Panlungsod ng Ormoc, That:

SECTION 1. 2016 GENERAL FUND SUPPLEMENTAL BUDGET. The sum of SIX MILLION THREE HUNDRED FIFTY FIVE THOUSAND AND FIVE HUNDRED PESOS (P6,355,500.00) of the General Fund Supplemental Budget of Ormoc City is hereby appropriated to supplement the account- Donations – of OSCA, for the payment of Senior Citizens Birthday Gifts for the months of October 2016 to December 2016, to be taken from the Unappropriated Surplus, end of year 2015 of the General Fund.

SECTION 2. EFFECTIVITY. This Appropriation Ordinance shall take effect immediately upon its approval subject however, to the compliance of the posting and publication requirements as provided in the Local Government Code of 1991.

RESOLVED, FURTHER, that sufficient copies of this Appropriation Ordinance together with all supporting documents be submitted to the Honorable Secretary, Department of Budget & Management, Manila, through the City Budget Officer of Ormoc and the Regional Director, Department of Budget & Management, Tacloban City, for review purposes;


ENACTED, December 01, 2016.


