PREFATORY STATEMENT

WHEREAS, presented to this august Body for consideration is an Indorsement dated December 13, 2016 from the City Mayor Richard I. Gomez urgently requesting for a supplemental appropriation in the amount of THREE MILLION EIGHT HUNDRED EIGHTY THOUSAND PESOS (P3,880,000.00) for the Productivity Enhancement Incentive (PEI) of regular and casual employees, including city officials of the Local Government Unit of Ormoc for FY 2016 in accordance with the provisions of Budget Circular No. 2016-8 dated December 12, 2016. The incentive is set at FIVE THOUSAND PESOS (P5,000.00) for each official/employee who are still in the service as of November 30, 2016 and have rendered at least a total or an aggregate of Four (4) months of at least satisfactory service as of November 30, 2016, including leaves of absence with pay, subject however to pro rata in case of qualified employees who have rendered less than the required total or aggregate of four (4) months service.

WHEREAS, the grant of PEI to LGU officials and employees is pursuant to Executive Order (EO) No. 201, S.2016, specifically Section 6, thereof which states that:

"Beginning FY 2016, the Productivity Enhancement Incentive shall be given not earlier than December 15 of every year to all qualified government employees at Five Thousand Pesos (P5,000.00) each for the purpose of improving the government employees' productivity".

WHEREAS, furthermore, the provision of PEI is also authorized under Executive Order No. 203 on the Compensation and Position Classification System (CPCS) and General Index of Occupational Services (IOS) for the GOCC Sector covered by RA No. 10149, particularly Item 4.2 thereof which provides that:

"Productivity Enhancement Incentive (PEI) - The PEI as determined by the Department of Budget and Management (DBM) shall be granted across-the-board to qualified officers and employees"

WHEREAS, relative thereto, the Human Resource Management Officer submitted a summary of the total number of officials and employees who are qualified to receive such benefit, the breakdown of which is as follows:

BE IT ENACTED, by the Fourteenth Sangguniang Panlungsod ng Ormoc, That:

SECTION 1. <u>2016 GENERAL FUND SUPPLEMENTAL BUDGET</u>. The sum of THREE MILLION EIGHT HUNDRED EIGHTY THOUSAND PESOS (P3,880,000.00) of the General Fund Supplemental Budget of Ormoc City is hereby appropriated for the payment of Productivity Enhancement Incentive (PEI) of the city officials and employees of LGU- Ormoc for FY 2016 to be sourced from out of the Unappropriated Surplus, end of year 2015.

SECTION 2. <u>EFFECTIVITY</u>. This Appropriation Ordinance shall take effect immediately upon its approval.

RESOLVED, FURTHER, that sufficient copies of this Appropriation Ordinance, together with all supporting documents thereof, be submitted to the Hororable Secretary of Department of Budget and Management, Manila, through the City Budget Officer of Ormoc, and the Regional Director, Department of Budget & Management, Tacloban City, for review purposes;
