PREFATORY STATEMENT

WHEREAS, an Indorsement dated March 13, 2017 from the City Mayor Richard I. Gomez was received by this august Body requesting for urgent action on the request of the OIC-City Assessor, Engr. Arthur C. Arcuino for reversion of the Continuing Appropriation for Office Equipment of the City Assessor's Office (CAO) in the amount of ONE HUNDRED SEVENTY THOUSAND PESOS (P170,000.00) to augment the appropriation of the account- Capital Outlay: Motor Vehicle of same office;

WHEREAS, the reverted funds will serve as additional appropriation for the purchase of Motor Vehicle to be used by CAO in its day to day operations and effectively perform its mandate, specifically in the intensified Assessment and Appraisal of Real Properties within the city in order to meet its target of accomplishing the desired Real Property Tax (RPT) revisions by 2018;

WHEREAS, the City Budget Officer, City Accountant, and City Treasurer issued a certification dated March 6, 2017 stating therein that funds are available for reversion to carry out the aforementioned purpose of CAO as provided hereunder, to wit:

RESOLVED, AS IT IS HEREBY RESOLVED, to enact:

**APPROPRIATION ORDINANCE NO. 2017-002
(General Fund)**

AN ORDINANCE REVERTING AND APPROPRIATING THE AMOUNT OF ONE HUNDRED SEVENTY THOUSAND PESOS (P170,000.00) TO BE TAKEN FROM OUT OF THE REVERSION OF THE CY 2010 CONTINUING APPROPRIATION FOR OFFICE EQUIPMENT OF THE CITY ASSESSOR'S OFFICE TO AUGMENT THE APPROPRIATION OF THE ACCOUNT- CAPITAL OUTLAY: MOTOR VEHICLE OF SAME OFFICE.

BE IT ENACTED, by the Fourteenth Sangguniang Panlungsod ng Ormoc in Regular Session assembled, That:

SECTION 1. 2017 GENERAL FUND SUPPLEMENTAL BUDGET. The sum of ONE HUNDRED SEVENTY THOUSAND PESOS (P170,000.00) of the General Fund Supplemental Budget of Ormoc City is hereby reverted and appropriated for the account- Capital Outlay: Motor Vehicle of the City Assessor's Office to be taken from out of the reversion of the CY 2010 Continuing Appropriation for Office Equipment of same office.

SECTION 2. EFFECTIVITY. This Appropriation Ordinance shall take effect immediately upon its approval.




