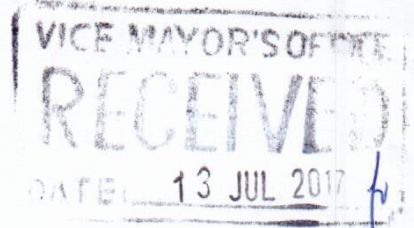

PREFATORY STATEMENT

WHEREAS, forwarded to this august Body for consideration, is an Indorsement dated June 19, 2017, from the City Mayor Richard I. Gomez, requesting for a supplemental appropriation in the total amount of FORTY MILLION PESOS (P40,000,000.00), to be taken from the Unappropriated Surplus, end of year 2016 for the Design and Build for the Upgrading and Improvement of Ahag Water Treatment Plant (Ahag WTP);

WHEREAS, the funding requirement of the project is imperative in line with Ormoc Waterworks Office' (ORWASA) goal to enhance its services and to carry out the administration's thrust for the continued improvement and development of the city's water supply system particularly the Ahag Water Treatment Plant;

WHEREAS, at present many barangays in the city are confronted with water supply problems thus, the proposed development of Ahag WTP which is one of the major water sources of a number of city barangays is deemed most beneficial and will have a great impact in addressing the water issue hence, the need to be funded for its immediate implementation;

WHEREAS, through a certification dated June 15, 2017 the City Budget Officer and the City Treasurer stated that the amount of FORTY MILLION PESOS (P40,000,000.00) is deemed available for the Design and Build for the Upgrading and Improvement of Ahag Water Treatment Plant (Ahag WTP) to be taken from the Unappropriated Surplus, end of year 2016, to wit:

General Fund	P 31,000,000.00
Ormoc Waterworks	9,000,000.00

APPROPRIATION ORDINANCE NO. 2017-016
(General Fund)

AN ORDINANCE APPROPRIATING THE AMOUNT OF FORTY MILLION PESOS (P40,000,000.00), FOR THE DESIGN AND BUILD FOR THE UPGRADING AND IMPROVEMENT OF AHAG WATER TREATMENT PLANT (AHAG WTP), TO BE TAKEN FROM THE UNAPPROPRIATED SURPLUS, END OF YEAR 2016, TO WIT:

GENERAL FUND	P 31,000,000.00
ORMOC WATERWORKS	9,000,000.00

TOTAL	P 40,000,000.00

BE IT ENACTED, by the Fourteenth Sangguniang Panlungsod ng Ormoc, That:

SECTION 1. 2017 GENERAL FUND SUPPLEMENTAL BUDGET. The sum of FORTY MILLION PESOS (P40,000,000.00) of the General Fund Supplemental Budget of Ormoc City is hereby appropriated for the aforementioned object of expenditures of ORWASA Office to be taken from the Unappropriated Surplus, end of year 2016 of same office and from the General Fund.

SECTION 2. EFFECTIVITY. This Appropriation Ordinance shall take effect immediately upon its approval subject however, to the compliance of the posting and publication requirements as provided in the Local Government Code of 1991.

RESOLVED, FURTHER, that sufficient copies of this Appropriation Ordinance together with all supporting documents be submitted to the Honorable Secretary, Department of Budget & Management, Manila, through the City Budget Officer of Ormoc and the Regional Director, Department of Budget & Management, Tacloban City, for review purposes;


ENACTED, July 13, 2017.


