PREFATORY STATEMENT

WHEREAS, the Office of the City Mayor issued an Endorsement dated October 4, 2017 to this august Body for consideration, relative to the request of SP Member Vincent L. Rama, Chairman, Committee on Social Welfare, Senior Citizens Women and Family, for a supplemental appropriation amounting to FIVE MILLION SEVEN HUNDRED SIXTY SIX THOUSAND PESOS (P5,766,000.00) for the payment of Birthday Gifts of qualified Senior Citizens of Ormoc City for the last quarter of CY 2017;

WHEREAS, the granting of Birthday Gifts to Ormoc City Senior Citizens celebrants is in accordance with Ordinance No. 184 dated June 20, 2013, entitled: "AN ORDINANCE GRANTING A BIRTHDAY GIFT TO BONA FIDE SENIOR CITIZEN RESIDENTS OF ORMOC CITY AND APPROPRIATING FUNDS THEREOF" as amended;

WHEREAS, to recall the CY 2017 appropriated Budget of the Office of the Senior Citizens Affairs (OSCA) for the implementation of the Birthday Gift Program totals to Seventeen Million Pesos (P17,000,000.00);

WHEREAS, in view of the increasing number of qualified Ormoc City Senior Citizens availing of said Birthday Gift, the appropriated amount for CY 2017 was depleted thus, the need to be supplemented in order to cover the remaining recipients of such benefit for the last quarter of the current year;

WHEREAS, a certification dated September 29, 2017 from the Offices of the City Budget Officer, City Treasurer, and OIC-City Accountant was issued, certifying therein that the amount of FIVE MILLION SEVEN HUNDRED SIXTY SIX THOUSAND PESOS (P5,766,000.00) as additional appropriation for Senior Citizens Welfare and Assistance Program under the account - Subsidy Others - is deemed available to be taken from the Unappropriated Surplus, end of year 2016 to be used specifically for the payment of subject Birthday Gifts;

RESOLVED, to enact:

**APPROPRIATION ORDINANCE NO. 2017-022  
(General Fund)**

**AN ORDINANCE APPROPRIATING THE AMOUNT OF FIVE MILLION SEVEN HUNDRED SIXTY SIX THOUSAND PESOS (P5,766,000.00) TO BE TAKEN FROM THE UNAPPROPRIATED SURPLUS, END OF YEAR 2016 AS ADDITIONAL APPROPRIATION FOR THE SENIOR CITIZENS WELFARE AND ASSISTANCE PROGRAM UNDER THE ACCOUNT – SUBSIDY OTHERS – OF THE OFFICE OF THE SENIOR CITIZENS AFFAIRS (OSCA), TO COVER THE PAYMENT OF SENIOR CITIZENS' BIRTHDAY GIFT FOR THE MONTHS OF OCTOBER, NOVEMBER, AND DECEMBER, 2017.**

BE IT ENACTED, by the Fourteenth Sangguniang Panlungsod ng Ormoc,  
That:

**SECTION 1. 2017 GENERAL FUND SUPPLEMENTAL BUDGET.** The sum of FIVE MILLION SEVEN HUNDRED SIXTY SIX THOUSAND PESOS (P5,766,000.00) of the General Fund Supplemental Budget of Ormoc City is hereby appropriated to supplement the Senior Citizens Welfare and Assistance Program under the account-Subsidy Others – of OSCA, for the payment of Senior Citizens Birthday Gifts for the months of October 2017 to December 2017, to be taken from the Unappropriated Surplus, end of year 2016.

**SECTION 2. EFFECTIVITY.** This Appropriation Ordinance shall take effect immediately upon its approval subject however, to the compliance of the posting and publication requirements as provided in the Local Government Code of 1991.

RESOLVED, FURTHER, that sufficient copies of this Appropriation Ordinance together with all supporting documents be submitted to the Honorable Secretary, Department of Budget & Management, Manila, through the City Budget Officer of Ormoc and the Regional Director, Department of Budget & Management, Tacloban City, for review purposes;




