PREFATORY STATEMENT

WHEREAS, presented to the Fourteenth Sangguniang Panlungsod ng Ormoc for consideration is an Endorsement dated September 20, 2017 from the office of the City Mayor, requesting for a supplemental appropriation in the total amount of TWENTY SEVEN MILLION PESOS (P27,000,000.00), to be taken from the Unappropriated Surplus end of year, 2016 as additional appropriation for the account - Public Employment Services Program (PESP) of the City Mayor's Office;

WHEREAS, the funds requested will be utilized to cover the deficiency of appropriation for the Job Orders compensation for the month of October 2017 to December 2017;

WHEREAS, the services of these Job Orders are indispensable to the LGU's smooth operation and efficient administration hence, the need for this supplemental appropriation to cover their wages for the last quarter of CY 2017 to ensure the continuity of their services so that public service will not be hampered;

WHEREAS, the City Budget Officer, the City Treasurer, and the OIC-City Accountant, issued a certification dated September 19, 2017, stating therein that the amount of TWENTY SEVEN MILLION PESOS (P27,000,000.00), is deemed available to be taken from the Unappropriated Surplus, end of year 2016 of the General Fund as additional appropriation for the account - Public Employment Services program (PESP) of the City Mayor's Office, broken down as follows:

RESOLVED, to enact:

APPROPRIATION ORDINANCE NO. 2017-023
(General Fund)

AN ORDINANCE APPROPRIATING THE AMOUNT OF TWENTY SEVEN MILLION PESOS (P27,000,000.00) TO BE TAKEN FROM THE UNAPPROPRIATED SURPLUS, END OF YEAR 2016 OF THE GENERAL FUND, AS ADDITIONAL APPROPRIATION FOR THE ACCOUNT - PUBLIC EMPLOYMENT SERVICES PROGRAM (PESP) OF THE CITY MAYOR'S OFFICE TO COVER THE WAGES OF JOB ORDERS FOR THE MONTHS OF OCTOBER, NOVEMBER, AND DECEMBER, 2017.

BE IT ENACTED, by the Fourteenth Sangguniang Panlungsod ng Ormoc,
That:

SECTION 1. 2017 GENERAL FUND SUPPLEMENTAL BUDGET. The sum of TWENTY SEVEN MILLION PESOS (P27,000,000.00) of the General Fund Supplemental Budget of Ormoc City is hereby appropriated as additional appropriation for the account- Public employment Services Program (PESP) of the City Mayor's Office, to be taken from the Unappropriated Surplus, end of year 2016.

SECTION 2. EFFECTIVITY. This Appropriation Ordinance shall take effect immediately upon its approval subject however, to the compliance of the posting and publication requirements as provided in the Local Government Code of 1991.


