PREFATORY STATEMENT

WHEREAS, presented to the 14<sup>th</sup> Sangguniang Panlungsod ng Ormoc for consideration is an Endorsement dated September 22, 2017 from the City Mayor Richard I. Gomez in connection with the letter request of Engr. Domardoni C. Cayanong, City General Services Officer, for reversion of funds in the amount of One Hundred Thirty Five Thousand Pesos (P135,000.00) to be taken from the Calendar Year 2014 Continuing Appropriation account - Other Property, Plant and Equipment of the General Services Office (GSO) to supplement the Capital Outlay account- Office Equipment of same office as additional funds for the purchase of One (1) unit Multifunctional Photocopy Machine;

WHEREAS, the procurement of Multifunctional Photocopy Machine by the GSO is deemed a priority expenditure that has to be carried out by said office considering that its existing Photocopy Machine is no longer serviceable due to wear and tear;

WHEREAS, the GSO is one of the key offices of the LGU wherein innumerable office transactions are passing through daily hence, it is indeed necessary that a Photocopier be acquired by the said office to speed up the reproduction of vital documents supporting each transaction for the convenience of the transacting public and to improve the office productivity and efficiency ;

WHEREAS, a Certification dated September 22, 2017 was issued by the City Budget Officer, City Treasurer, and OIC-City Accountant certifying therein that the amount covered by the proposed reversion amounting to One Hundred Thirty Five Thousand Pesos (P135,000.00) is deemed available to be taken from the reversion of the CY 2014 Continuing Appropriation as follows:

**APPROPRIATION ORDINANCE NO. 2017-025  
(General Fund)**

**AN ORDINANCE REVERTING AND APPROPRIATING THE AMOUNT OF ONE HUNDRED THIRTY FIVE THOUSAND PESOS (P135,000.00) TO BE TAKEN FROM OUT OF THE REVERSION OF THE CALENDAR YEAR 2014 CONTINUING APPROPRIATION ACCOUNT - OTHER PROPERTY, PLANT AND EQUIPMENT OF THE GENERAL SERVICES OFFICE (GSO) TO SUPPLEMENT THE ACCOUNT- OFFICE EQUIPMENT OF SAME OFFICE AS ADDITIONAL FUNDS FOR THE PURCHASE OF ONE (1) UNIT BRAND NEW MULTIFUNCTIONAL PHOTOCOPY MACHINE.**

BE IT ENACTED, by the Fourteenth Sangguniang Panlungsod ng Ormoc in Regular Session assembled, That:

**SECTION 1. 2017 GENERAL FUND SUPPLEMENTAL BUDGET.** The sum of of ONE HUNDRED THIRTY FIVE THOUSAND PESOS (P135,000.00) of the General Fund Supplemental Budget of Ormoc City is hereby reverted and appropriated to the account-Office Equipment of the General Services Office as additional funds for the purchase of One (1) unit brand new multifunctional photocopy machine to be taken from out of the reversion of the CY 2014 Continuing Appropriation- Other Property, Plant and Equipment of same office.

**SECTION 2. EFFECTIVITY.** This Appropriation Ordinance shall take effect immediately upon its approval.

RESOLVED, FURTHER, that sufficient copies of this Appropriation Ordinance, together with all supporting documents thereof, be submitted to the Honorable Secretary of Department of Budget and Management, Manila, through the City Budget Officer of Ormoc, and the Regional Director, Department of Budget & Management, Tacloban City, for review purposes;


