PREFATORY STATEMENT

WHEREAS, the Sangguniang Panlungsod was in receipt of an urgent Endorsement Letter from the City Mayor's Office (CMO), dated September 27, 2018, respectfully endorsing the request of Engr. Fulton Emmanuel S. Manawatao, OIC-Head of Office, for the Reversion of Funds in the total amount of TWO MILLION ONE HUNDRED EIGHTY ONE THOUSAND SEVEN HUNDRED EIGHTY THREE PHILIPPINE PESOS & 53/100 (PHP2,181,783.53) to be taken from the reversion of Continuing Appropriation - 20% Development Fund for the following projects, to wit:

WHEREAS, the requested amount for reversion is deemed necessary for the installation of a new pipeline in Brgy. San Pablo to replace the existing pipeline that is easily and heavily damaged and affected by weather disturbances, and for the repair and replacement of identified damaged pipelines in Brgy. San Antonio, Matica-a, Margen, Mas-in, Curva, Licuma, Luna and Guintigui-an, all for the reduction of interruption of water services in the said areas;

WHEREAS, the City Budget Office, the City Accountant and City Treasurer issued a Certification of Availability of Funds dated September 26, 2018 stating therein that the amount of TWO MILLION ONE HUNDRED EIGHTY ONE THOUSAND SEVEN HUNDRED EIGHTY THREE PHILIPPINE PESOS AND 53/100 to be taken from reversion of Continuing Appropriation – 20% Development Fund under the account Improvement of Water Treatment Facility @ Brgy. Bantigue and Patag 2017 is deemed available, a copy of said certification is attached as Annex "A" and made an integral part hereof;

WHEREAS, the request for the reversion of funds by the OIC-Head of Office, Ormoc Waterworks Office, as endorsed by the CMO, is found to be justified, reasonable and meritorious as the reverted amount will be used for the improvement and repair of pipelines of the Ormoc Waterworks Office as part of its on-going efforts in providing reliable and uninterrupted water supply for the benefit of the constituents of Ormoc City and the general public, and not contrary to existing accounting, auditing laws, rules and regulations;

WHEREFORE, FOREGOING PREMISES CONSIDERED, on motion of SP Member Nolito M. Quilang, Member, Committee on Finance & Appropriation, duly seconded by SP Member Tomas R. Serafica: be it

AN ORDINANCE REVERTING AND APPROPRIATING THE AMOUNT OF TWO MILLION ONE HUNDRED EIGHTY ONE THOUSAND SEVEN HUNDRED EIGHTY THREE PHILIPPINE PESOS AND 53/100 (PHP2,181,783.53) TO BE TAKEN FROM THE REVERSION OF CONTINUING APPROPRIATION – 20% DEVELOPMENT FUND UNDER THE ACCOUNT IMPROVEMENT OF WATER TREATMENT FACILITY AT BRGY. BANTIGUE AND PATAG 2017 FOR THE FOLLOWING PROJECTS, TO WIT:

BE IT ENACTED, by the Fourteenth Sangguniang Panlungsod of Ormoc in Regular Session assembled, that:

SECTION 1. CY 2018 GENERAL FUND SUPPLEMENTAL BUDGET. The amount of TWO MILLION ONE HUNDRED EIGHTY ONE THOUSAND SEVEN HUNDRED EIGHTY THREE PHILIPPINE PESOS & 53/100 (PHP2,181,783.53) from Continuing Appropriation – 20% Development Fund under the account Improvement of Water Treatment Facility @Brgy. Bantigue & Patag 2017 is hereby reverted and appropriated to the aforementioned account for the implementation of the project Rehab/Improvement/Expansion of Ormoc Water System Facilities – Pipeline Installation (Level III) in the aforementioned barangays.

SECTION 2. EFFECTIVITY. This Appropriation Ordinance shall take effect immediately upon its approval.


