## PREFATORY STATEMENT

WHEREAS, the Sangguniang Panlungsod was in receipt of an Endorsement Letter from the City Mayor's Office, dated November 5, 2018, respectfully endorsing the request of Rafael Junnar P. Dumalan, Environmental Management Specialist II, Supplemental Appropriation in the total amount of TWO MILLION PHILIPPINE PESOS (PHP2,000,000.00) as an additional appropriation of the account Fuel, Oil and Lubricant Expenses of the Environment and Natural Resources Office (ENRO);

WHEREAS, the requested supplemental appropriation is for the provision of fuel, oil and lubrication of garbage collection vehicles under the Solid Waste Management Program of the City of Ormoc for the months of October, November and December of 2018;

WHEREAS, the FIVE MILLION FOUR HUNDRED NINETY-SIX THOUSAND THREE HUNDRED FIFTY PHILIPPINE PESOS (PHP5,496,350.00) CY 2018 Appropriation for the account Fuel, Oil & Lubricant Expenses of the ENRO is deemed insufficient because ONE MILLION EIGHT HUNDRED THOUSAND PHILIPPINE PESOS (PHP1,800,000.00) of the same was used to augment other accounts related to Solid Waste Management, particularly for purposes including, but not limited to, the payment of backhoe rentals, and repairs and maintenance of the same and other garbage collection vehicles;

WHEREAS, the City Budget Officer, the City Accountant and City Treasurer issued a Certification of Availability of Funds dated October 31, 2018 stating therein that the amount of TWO MILLION PHILIPPINE PESOS (PHP2,000,000.00) to be used as an additional appropriation of the account – Fuel, Oil & Lubricant Expenses – of the ENRO is deemed available to be taken from the Unappropriated Surplus End of Year 2017;

WHEREAS, this Sanggunian finds that the endorsed request for appropriation of funds is justified, reasonable and meritorious as it is geared towards a continuous and uninterrupted delivery of services of the city relative to the collection of garbage and its proper disposal as part of the city's effort in maintaining a clean and healthful environment all for the benefit of the general public;

WHEREFORE, FOREGOING PREMISES CONSIDERED, on motion of SP Member Nolito M. Quilang, Jr., Member, Committee on Finance & Appropriation, severally seconded by SP Members Tomas R. Serafica, Eusebio Gerardo S. Penserga, Gregorio G. Yrastorza III and Esteban V. Laurente: be it

RESOLVED, AS IT IS HEREBY RESOLVED, to enact:

## APPROPRIATION ORDINANCE NO. 2018-033

AN ORDINANCE APPROPRIATING THE AMOUNT OF TWO MILION PHILIPPINE PESOS (PHP2,000,000.00) TO BE TAKEN FROM THE UNAPPROPRIATED SURPLUS END OF YEAR 2017 AS AN ADDITIONAL APPROPRIATION OF THE ACCOUNT - FUEL, OIL & LUBRICANT EXPENSES - OF THE ENVIRONMENT AND NATURAL RESOURCES OFFICE (ENRO) FOR THE PROVISION OF FUEL, OIL & LUBRICATION OF ITS GARBAGE COLLECTION VEHICLES FOR THE MONTHS OF OCTOBER, NOVEMBER AND DECEMBER 2018.

BE IT ENACTED, by the Fourteenth Sangguniang Panlungsod of Ormoc in Regular Session assembled, that:

SECTION 1. CY 2018 GENERAL FUND SUPPLEMENTAL BUDGET. The amount of TWO MILLION PHILIPPINE PESOS (PHP2,000,000.00) from the Unappropriated Surplus End of Year 2017 is hereby appropriated to the Fuel, Oil & Lubricant Expenses account of the ENRO for abovementioned purpose.

SECTION 2. EFFECTIVITY. This Appropriation Ordinance shall take effect immediately upon its approval.

RESOLVED, FURTHER, that sufficient copies of this Appropriation Ordinance, together with all supporting documents thereof, be submitted to the Honorable Secretary of Department of Budget and Management, Manila, through the City Budget Officer of Ormoc and the Regional Director, Department of Budget & Management, Tacloban City, for review purposes;
