## PREFATORY STATEMENT

WHEREAS, this Sanggunian was in receipt of an Endorsement Letter from the Office of the City Mayor dated June 17, 2019, respectfully requesting for a Supplemental Appropriation in the total amount of ONE MILLION FOUR HUNDRED THOUSAND PHILIPPINE PESOS (PHP1,400,000.00) for payment of Mid-Year Bonus (MYB) of qualified Casual Employees for CY 2019;

WHEREAS, the abovementioned request for supplemental appropriation shall be taken from reversion of various Personal Services (PS) Savings Account of the Traffic Enforcement and Management (TEAM) Office for the period January to June 2019, as indicated in L&P Form No. 8, Statement of Funding Sources FY 2019, a copy of said form is attached herein as Annex "A" and made an integral part hereof, to wit:

WHEREAS, a total of One Hundred twenty-eight (128) casual employees of LGU-Ormoc have not yet received their Mid-Year Bonus by reason of the deficiency in the budget, a copy of the list of the total number of employees entitled of the same and the corresponding amount is attached hereto as Annex "B" and made an integral part hereof;

WHEREAS, LBP Form No. 9 Supplemental Appropriation CY 2019, was prepared by the City Budget Officer and approved by the City Mayor, a copy of said form is attached hereto as Annex "C" and made an integral part hereof;

WHEREAS, this Sanggunian finds that the endorsed request for a supplemental appropriation for the aforementioned purpose, supported by relevant justification and documents, is found to be justified, reasonable, necessary and MYB of qualified Casual Employees which is an authorized personnel benefit, mandatory in nature, and obligates LGU-Ormoc to provide the same to the entitled employees;

# APPROPRIATION ORDINANCE NO. 001 (Series of 2019)

AN ORDINANCE REVERTING AND APPROPRIATING THE AMOUNT OF ONE MILLION FOUR HUNDRED THOUSAND PHILIPPINE PESOS (PHP1,400,000.00) TO BE TAKEN FROM VARIOUS PERSONAL SERVICES (PS) SAVINGS ACCOUNT OF THE TRAFFIC ENFORCEMENT AND MANAGEMENT (TEAM) OFFICE FOR THE PAYMENT OF THE MID-YEAR BONUS (MYB) OF QUALIFIED CASUAL EMPLOYEES FOR CALENDAR YEAR 2019.

BE IT ENACTED, by the Fifteenth Sangguniang Panlungsod of Ormoc in Regular Session assembled, that:
