PREFATORY STATEMENT

WHEREAS, the 14th Sangguniang Panglungsod ng Ormoc was in receipt of an Endorsement Letter from the City Mayor's Office dated April 26, 2019 respectfully endorsing the request of Engr. Ranulfo D. Oliveros, City Engineer, for Reversion of Funds in the total amount of THREE MILLION SIX HUNDRED NINETY-FOUR THOUSAND SIX HUNDRED EIGHTY-NINE PHILIPPINE PESOS (PHP3,694,689.00) to be taken from the reversion of Continuing Capital Outlay accounts of the City Engineering Office to wit:

WHEREAS, the requested amount to be reverted is for the purchase of three (3) units service vehicles to be used by the requesting office for the use of the technical personnel in conducting surveys and inspection of proposed & on-going projects of the city;

WHEREAS, LBP Form No. 8, Statement of Funding Sources FY 2019, was issued and signed by the OIC-City Treasurer and City Accountant indicating therein that the amount of THREE MILLION SIX HUNDRED NINETY-FOUR THOUSAND SIX HUNDRED EIGHTY-NINE PHILIPPINE PESOS (PHP3,694,689.00) shall be taken from the reversion of the Continuing Appropriation accounts of the Office of the City Engineer, a copy of said form is attached hereto as Annex "A" and made an integral part hereof;

WHEREAS, LBP Form No. 9, Statement of Supplemental Appropriation CY 2019, was issued and signed by the City Budget Officer and approved by the City Mayor, a copy of said form is attached hereto as Annex "B" and made an integral part hereof;

WHEREAS, the OIC-City Treasurer and the City Budget Officer issued a certification dated April 29, 2019, attested by the City Mayor, stating therein that the amount of THREE MILLION SIX HUNDRED NINETY-FOUR THOUSAND SIX HUNDRED EIGHTY-NINE PHILIPPINE PESOS (PHP3,694,689.00) to be taken from the Continuing Appropriation accounts of the Office of the City Engineer is available for reversion, a copy of said certification is hereto attached as Annex "C" and made an integral part hereof;

WHEREAS, the endorsed request is found to be justified and reasonable as the purchase of said vehicles is geared towards the improvement of the efficiency and effectiveness of the requesting office's delivery of service, and would greatly redound to the benefit of the city's constituents and to the general public;

SECTION 1. <u>CY 2019 GENERAL FUND SUPPLEMENTAL BUDGET.</u> The amount of THREE MILLION SIX HUNDRED NINETY-FOUR THOUSAND SIX HUNDRED EIGHTY-NINE PHILIPPINE PESOS (PHP3,694,689.00) from various Continuing Appropriation accounts of the Office of the City Engineer abovementioned is hereby reverted and appropriated for the purchase of three (3) units of service vehicles.

SECTION 2. EFFECTIVITY. This Appropriation Ordinance shall take effect immediately upon its approval.

RESOLVED, FURTHER, that sufficient copies of this Appropriation Ordinance, together with all supporting documents thereof, be submitted to the Honorable Secretary of Department of Budget and Management, Manila, through the City Budget Officer of Ormoc and the Regional Director, Department of Budget & Management, Tacloban City, for review purposes;
