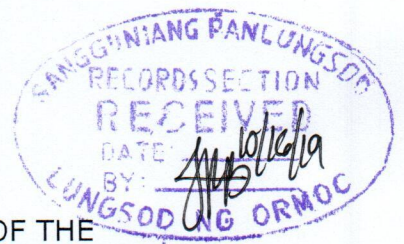

PREFATORY STATEMENT

WHEREAS, the Sangguniang Panlungsod was in receipt of an Indorsement Letter from the City Mayor's Office (CMO), relative to the request of Engr. Fulton Emmanuel S. Manawatao, ORWASA Acting Head Office, dated September 11, 2019, requesting for a Supplemental Appropriation in the total amount of EIGHT MILLION TWO HUNDRED THOUSAND PHILIPPINE PESOS (PHP8,200,000.00) for the various projects of the Ormoc Waterworks and Sewerage Administration (ORWASA) Office;

WHEREAS, the City Budget Officer and the City Treasurer issued LBP Form No.8 – Statement of Funding Sources, FY 2019 indicating therein that the requested amount of EIGHT MILLION TWO HUNDRED THOUSAND PHILIPPINE PESOS (PHP8,200,000.00) be taken from the City's Savings for FY 2018, a copy of which is hereto attached and designated as Annex "A" hereof;

WHEREAS, the supplemental request of the ORWASA Office is to augment the Water Supply System account as stated in LBP Form No. 9 duly provided by the City Budget Officer and approved by the City Mayor, a copy of the form is hereto attached and designated as Annex "B" hereof, with the following purposes, to wit:

SECTION 1. CY 2019 GENERAL FUND SUPPLEMENTAL BUDGET. The total sum of EIGHT MILLION TWO HUNDRED THOUSAND PHILIPPINE PESOS (PHP8,200,000.00) chargeable against Unappropriated Surplus end of 2018 for the various projects of the ORWASA Office.

SECTION 2. EFFECTIVITY. This Appropriation Ordinance shall take effect immediately upon its approval.



CARRIED UNANIMOUSLY.


