PREFATORY STATEMENT

WHEREAS, the Sangguniang Panlungsod was in receipt of an urgent Endorsement Letter from the City Mayor's Office dated December 4, 2019, respectfully requesting for a Supplemental Appropriation in the total amount of TWENTY-EIGHT MILLION TWENTY-SEVEN THOUSAND PHILIPPINE PESOS (PHP28,027,000.00) for the grant of the Collective Negotiation Agreement (CNA) Incentive to qualified regular and casual employees of the City Government of Ormoc, consistent with the Collective Negotiation Agreement by and between the City Government of Ormoc and the COGEA and the Department of Budget and Management (DBM) Budget Circular No. 2019-5, November 7, 2019;

WHEREAS, the provision of the CNA Incentive is anchored on the authority granted by law per Public Sector Labor Management Council (PSLMC) Resolution No. 4. 5. 2002 which authorizes the management and the accredited association to enter into Collective Negotiations on terms and conditions of employment which are not fixed by law, and DBM Circular No. 2019-5 dated November 7, 2019 which provides for the guidelines on the grant of the CNA Incentive to government employees for fiscal year 2019;

WHEREAS, the City of Ormoc Government Employees Association (COGEA), the sole, exclusive, and legitimate bargaining unit in the City of Ormoc having been jointly registered and accredited by the Department of Labor and Employment and Civil Service Commission evidenced by Certificate of Registration No. 1173 dated 10th of January 2003 and Accreditation No. 555 dated 19th of April 2006, issued Resolution No. 32 dated November 19, 2019, entitled "A Resolution Earnestly Requesting the Honorable City Mayor Richard I. Gomez to Approve, Grant and Release the 2019 Collective Negotiation Agreement (CNA) Incentive to the Government Employees of the City Government of Ormoc Consistent with the Collective Negotiation Agreement By and Between the City Government of Ormoc and the City of Ormoc Government Employees Association (COGEA) and the DBM Budget Circular No. 2019-5 Series of November 7, 2019.", a copy of said resolution is attached herein as Annex "A" and made an integral part hereof;

WHEREAS, the Employees Organization-Management Consultative Committee of the Local Government Unit of Ormoc issued Resolution No. 2019-01 dated November 28, 2019, providing for the guidelines on the grant of the CNA Incentive and further recommending to the head of agency to grant the CNA Incentive to all employees for fiscal year 2019, a copy of said resolution is attached herein as Annex "B" and made an integral part hereof;

WHEREAS, the amount to be received by each qualified employee is computed at TWENTY FIVE THOUSAND PHILIPPINE PESOS, subject to pro-rata relative to the number of months in the service in CY 2019;

WHEREAS, the Human Resource Management Officer submitted a summary of the total number of officials and employees who are qualified to receive subject incentive, the breakdown of which is as follows:

WHEREAS, this Sanggunian finds that the endorsed request for the supplemental appropriation is justified, reasonable and meritorious;

APPROPRIATION ORDINANCE NO. 023 (Series of 2019)

AN ORDINANCE REVERTING AND APPROPRIATING THE AMOUNT OF TWENTY-EIGHT MILLION TWENTY-**THOUSAND PHILIPPINE PESOS** (PHP28,027,000.00) FOR THE **PAYMENT** OF COLLECTIVE NEGOTIATION AGREEMENT (CNA) INCENTIVE OF QUALIFIED REGULAR AND CASUAL EMPLOYEES OF THE LOCAL GOVERNMENT UNIT OF ORMOC, AT TWENTY-FIVE THOUSAND PHILIPPINE PESOS (PHP25,000.00) EACH, SUBJECT TO PRO-RATA AS TO THE NUMBER OF MONTHS IN THE SERVICE IN CY 2019 - TO BE TAKEN FROM CURRENT YEAR REVERSION OF ALLOWABLE SAVINGS **FROM** MAINTENANCE AND **OTHER** OPERATING EXPENSES APPROPRIATIONS.

BE IT ENACTED, by the Fifteenth Sangguniang Panlungsod of Ormoc in Regular Session assembled, that:

SECTION 1. CY 2019 GENERAL FUND SUPPLEMENTAL BUDGET. The amount of TWENTY-EIGHT MILLION TWENTY-SEVEN THOUSAND PHILIPPINE PESOS (PHP28,027,000.00) of the Current Year allowable savings from Maintenance and Other Operating Expenses is hereby reverted and appropriated to the aforementioned purpose.

SECTION 2. EFFECTIVITY. This Appropriation Ordinance shall take effect immediately upon its approval.

RESOLVED, FURTHER, that sufficient copies of this Appropriation Ordinance, together with all supporting documents thereof, be submitted to the Honorable Secretary of Department of Budget and Management, Manila, through the City Budget Officer of Ormoc and the Regional Director, Department of Budget & Management, Tacloban City, for review purposes;

RESOLUTION NO. 2019-01

A RESOLUTION RECOMMENDING TO THE HEAD OF AGENCY THE GRANT OF COLLECTIVE NEGOTIATION AGREEMENT (CNA) INCENTIVE TO ALL EMPLOYEES OF THE LOCAL GOVERNMENT UNIT OF ORMOCFOR FISCAL YEAR 2019 AND SETTING UP THE GUIDELINES ON THE GRANT OF THE SAME CONSISTENT WITH ADMINISTRATIVE ORDER NO. 135, S 2005, CONGRESS JOINT RESOLUTION NO. 4, AND THE DBM BUDGET CIRCULAR 2019-5, SERIES OF NOVEMBER 7, 2019.

WHEREAS, PSLMC Resolution No. 4, s 2002 authorizes the management and the accredited association to enter into Collective Negotiation on terms and conditions of employment which are not fixed by law;

WHEREAS, the COGEA as recognized by the City, is the sole, exclusive and legitimate bargaining unit in the City Government of Ormoc having been jointly registered and accredited by the Department of Labor and Employment and Civil Service Commission, as evidenced by Certificate of Registration No. 1173 dated 10th day of January 2003 and Accreditation No. 555 dated 19th of April 2006 of which both are of this government;

WHEREAS, the Budget Circular No. 2019-5 dated November 7, 2019 issued by the Department of Budget and Management (DBM) provides the guidelines on the grant of CNA Incentive to government employees for fiscal year 2019;

WHEREAS, section 4.2 of the same Circular, provides the rate of the CNA Incentive which is subject to compliance of the conditions for the grant of CNA incentives and the availability of savings from allowable MOOE allotments;

WHEREAS, in accordance with section 5.1.1 and 5.1.3 of the same Budget Circular No. 2019-5 and the CNA, the amount of allowable MOOE Allotment in improvement measures identified in the CNAs and supplements thereto, and which was the result of the joint efforts of management and employees and that any excess amount from the allowable MOOE allotments after payment of the CNA Incentive shall be reverted to the General Fund;

WHEREAS, Executive Order No. 79, series of 2019, created the Employee's Organization-Management Consultative Committee of the Local Government Unit of Ormoc (LGU-Ormoc) for the following purposes: (i) determining if the LGU-Ormoc is qualified for the grant of CNA based on the compliance with the requirements under Budget Circular No. 2019-5 issued by the DBM, and (ii) if qualified, to review the agency's financial records and submit recommendations for approval of the agency head...;

WHEREAS, the City of Ormoc Government Employees Association (COGEA) passed Resolution No. 32, series of 2019, on November 19, 2019, earnestly requesting the Honorable City Mayor Richard I. Gomez to approve, grant, and release the 2019 CNA incentives to the government employees of the LGU-Ormoc pursuant to the CNA by and between the City Government of Ormoc and the COGEA and consistent with the DBM's Budget Circular 2019-5, series of November 7, 2019;

WHEREAS, on November 28, 2019, the Employee's Organization-Management Consultative Committee of the LGU-Ormec convened in order to determine whether employees of the LGU-Ormec are qualified for the grant of the incentives, and to review and determine the financial requirements for the release of said incentives, in response to the request of COGEA as embodied on its Resolution No. 32, series of 2019;

WHEREAS, per Financial Report of the City Budget Office as of October 31, 2019, the total unobligated balances generated from the MOOE expense items identified by Budget Circular No. 2019-5 amounts to: Php 82,353,529.96;

WHEREAS, as per certification from the Human Resource Management Office, the Total amount required for CNA Incentive for 549 regular employees and 689 casual employees computed at Php 25,000.00 each or pro-rated based on the number of months they rendered service is Php 28,027,000.00 to wit:

General Funds Proper	-Php 2	6,680,000.00
LEE Market	-Php	598,000.00

LEE Slaughterhouse	-Php	37,000.00
LEE Terminal	-Php	237,000.00

WHEREAS, in order to justify the amount to be given to each qualified employee, the Employees Organization-Management Consultative Committee of the City of Ormoc RESOLVED to adopt the guidelines based on employees' contribution to the accomplishment of performance target, efficiency, productivity or profitability as follows:

Section 1. The CY 2019 CNA Incentives for LGU Ormoc Offices shall be granted to qualified employees:

a. Those who are regular, casual plantilla employees, to include those who are no longer in service as of November 30, 2019 due to retirement, resignation, separation or transfer to other government offices, provided they have rendered service during the year, regardless of the number of months in which case their CNA Incentives shall be pro-rated based on the number of months they have rendered using the following scheme:

No. of Months	Corresponding Amount	
10 months – 12 months	P 25,000.00	
7 months – 9 months	18,000.00	
4 months – 6 months	12,000.00	
1 month – 3 months	5,000.00	

 Those who are on scholarship grants, on authorized attendance to training courses, seminars or similar activities, shall be entitled to CNA incentives since they are still considered in the government service;

c. Those who are administratively charged and found guilty but later on exonerated by proper authorities upon appeal of the case shall be entitled to back payment of CNA Incentive unless otherwise decided by competent authorities.

Section 2. The following employees shall not be entitled to CNA incentives for CY 2019:

a. Those who are on Job Order (JO) basis of employment;

b. Those who are found guilty and/or meted penalties during the year prior to the grant of the CNA incentive;

Section 3. As provided for in Section 2. Article IX of the signed CNA, an Agency Fee shall be deducted from non-union members who accepts and enjoy the benefits of this Agreement in the amount of Php 300.00 for each month of service rendered.

RESOLVED to furnish copies of this Resolution to Ormoc City Mayor, Richard I. Gomez for approval and endorsement to the 15Th Sangguniang Panlungsod for deliberation and issuance of an appropriate ordinance.
