WHEREAS, presented to the Fifteenth Sangguniang Panlungsod for consideration is an urgent Indorsement dated March 24, 2020 from the City Mayor Richard I. Gomez requesting for a supplemental appropriation in the total amount of FIFTY EIGHT MILLION FIVE HUNDRED NINETY THOUSAND ELEVEN PHILIPPINE PESOS (PAP 58,590,011.00) to fund the implementation of the First Tranche Compensation Adjustment for LGU-Ormoc officials and employees effective January 1, 2020 pursuant to DRM Local Budget Circular No. 121 and Gratuity Benefits of Job Order per Administrative Order No. 20 from the Office of the President;

BE IT ENACTED, by the Fifteenth Sangguniang Panlungsod ng Ormoc Regular Session assembled, That:

SECTION 1: 2020 GENERAL FUND SUPPLEMENTAL BUDGET. The sum of FIFTY EIGHT MILLION FIVE HUNDRED NINETY THOUSAND ELEVEN PHILIPPINE PESOS (PHP 58,590,011.00) is hereby appropriated to fund the implementation of the first tranche of compensation adjustment effective January 1, 2020 pursuant to DBM Local Budget Circular No. 121 dated January 24, 2020 and Gratuity Benefits of Job Order as per Administrative Order No. 20 signed on January 10, 2020, to be taken from the Unappropriated Surplus, end of year 2019.

SECTION 2. EFFECTIVITY. This Appropriation Ordinance shall take effect immediately upon its approval.
