PREFATORY STATEMENT

WHEREAS, the Sangguniang Panlungsod was in receipt of an urgent endorsement letter from the City Mayor's Office (CMO) dated July 6, 2020 requesting for a supplemental appropriation in the amount OF FOUR MILLION FIVE HUNDRED FORTY-SEVEN THOUSAND FIVE HUNDRED SEVEN PHILIPPINE PESOS AND ELEVEN CENTS (PHP4,547,507.11) for provision of 5% Disaster Risk Reduction and Management (DRRM) Fund from the accumulated Share from National Wealth for the years 2011-2014 in the amount of NINETY MILLION NINE HUNDRED FIFTY THOUSAND ONE HUNDRED FORTY-TWO PHILIPPINE PESOS AND TWENTY- SEVEN CENTS (PHP90,950,142.27);

WHEREAS, RA 7160 otherwise known as the Local Government Code of 1991 mandates that Local government units (LGUs) should set aside at least 5% of their estimated revenue from regular sources as LDRRM Fund to support pre-disaster preparedness programs and post-disaster activities. Further, 30% of the LDRRM Fund is allocated as Quick Response Fund (QRF) or stand-by fund for relief and recovery programs;

WHEREAS, the request was referred to the Offices of the City Budget Officer, City Accountant, and the City Treasurer for appropriate recommendations as to the funding source thereof and in this respect LBP No. 8 and LBP No. 9, herein attached as Annex "A" and "B" respectively, were consecutively issued by the concerned offices certifying therein that the amount of FOUR MILLION FIVE HUNDRED FORTY-SEVEN THOUSAND FIVE HUNDRED SEVEN PHILIPPINE PESOS AND ELEVEN CENTS (PHP4,547,507.11) is deemed available for the aforementioned purpose to be taken from the reversion of accumulated Share from National Wealth for the years 2011-2014 in the amount of NINETY MILLION NINE HUNDRED FIFTY THOUSAND ONE HUNDRED FORTY-TWO PHILIPPINE PESOS AND TWENTY- SEVEN CENTS (PHP90,950,142.27), to wit:

APPROPRIATION ORDINANCE NO. 016
(Series of 2020)

AN ORDINANCE APPROPRIATING THE TOTAL AMOUNT OF FOUR MILLION FIVE HUNDRED FORTY-SEVEN THOUSAND FIVE HUNDRED SEVEN PHILIPPINE PESOS AND ELEVEN CENTS (PHP 4,547,507.11) FOR PROVISION OF 5% DISASTER RISK REDUCTION AND MANAGEMENT (DRRM) FUND FROM THE ACCUMULATED SHARE FROM NATIONAL WEALTH FOR THE YEARS 2011-2014.

SECTION 1. CY 2020 GENERAL FUND SUPPLEMENTAL BUDGET. The total sum of FOUR MILLION FIVE HUNDRED FORTY-SEVEN THOUSAND FIVE HUNDRED SEVEN PHILIPPINE PESOS AND ELEVEN CENTS (PHP4,547,507.11) is hereby appropriated for the provision of 5% Disaster Risk Reduction and Management (DRRM) Fund from the accumulated Share from National Wealth for the years 2011-2014 in the amount of NINETY MILLION NINE HUNDRED FIFTY THOUSAND ONE HUNDRED FORTY-TWO PHILIPPINE PESOS AND TWENTY- SEVEN CENTS (PHP90,950,142.27).

SECTION 2. EFFECTIVITY. This Appropriation Ordinance shall take effect immediately upon its approval.


RESOLVED, FURTHER, that sufficient copies of this Appropriation Ordinance, together with all supporting documents thereof, be submitted to the Honorable Secretary of Department of Budget and Management, Manila, through the City Budget Officer of Ormoc and the Regional Director, Department of Budget & Management, Tacloban City, for review purposes;

ENACTED, July 07, 2020.

RESOLVED, FURTHERMORE, to furnish copies of this Appropriation Ordinance, one each to the City Mayor Richard I. Gomez; the City Administrator, Mr. Vincent L. Emnas; the City Legal Officer, Atty. Josephine M. Romero; the City Budget Officer; the City Accountant; the City Treasurer; the City Planning & Development Office; the CDRMO; the City Auditor; the City Local Government Operations Officer, DILG, Engr. Jesus Jeremy D. Bagares; and other offices concerned;

CARRIED by Ten (10) Affirmative Votes. SP Members Benjamin S. Pongos, Jr. and Nolito M. Quilang were out of the Session Hall during the voting.
