SECTION 1. CY 2020 GENERAL FUND SUPPLEMENTAL BUDGET. The total amount of NINETY-NINE THOUSAND FOUR HUNDRED PHILIPPINE PESOS (PHP99,400.00) of the General Fund Supplemental Budget of Ormoc City is hereby reverted and appropriated to Motor Vehicles Account of the Business Permits & Licensing Office (BPLO) for the purchase of One (1) Unit Motorcycle to be taken from out of the reversion of Continuing Appropriation – 2018 Office Equipment of the same Office.


SECTION 2. EFFECTIVITY. This Appropriation Ordinance shall take effect immediately upon its approval.
