PREFATORY STATEMENT

WHEREAS, the Sangguniang Panlungsod received an endorsement letter from the City Mayor's Office (CMO) dated September 9, 2020 requesting for the reversion of funds in the amount of FOUR HUNDRED THOUSAND PHILIPPINE PESOS (PHP400,000.00) from the Current and Continuing Appropriations of Ormoc City Superdome for the additional purchase of Four (4) Units Speakers and One (1) Lot CCTV Equipment and Accessories;

WHEREAS, the request was referred to the Offices of the City Budget Officer, City Accountant, and the City Treasurer for appropriate recommendations as to the funding source thereof and in this respect LBP No. 8 and LBP No. 9 were consecutively issued by the concerned offices certifying therein that the amount of FOUR HUNDRED THOUSAND PHILIPPINE PESOS (PHP400,000.00) is deemed available for the aforementioned purpose to be taken from the reversion of Current and Continuing Appropriations of Ormoc City Superdome, herein attached as Annex "A" and "B" respectively, to wit:
