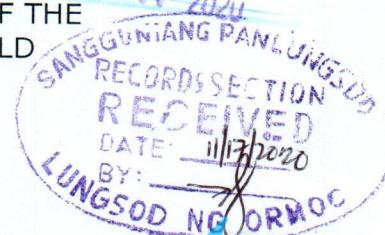
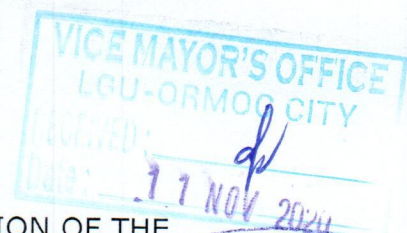

PREFATORY STATEMENT

WHEREAS, the Sangguniang Panlungsod was in receipt of an extremely urgent endorsement letter from the City Mayor's Office (CMO) dated October 27, 2020 requesting for the realignment of continuing appropriation of the 70% of Local Disaster Risk Reduction and Management (LDRRM) Funds in the amount of FIFTEEN MILLION FIVE HUNDRED THOUSAND PHILIPPINE PESOS (PHP15,500,000.00) to support the city's ongoing COVID-19 Response Operations and Programs;

WHEREAS, Presidential Proclamation No. 1021 proclaimed the extension of the State of Calamity in the Philippines to afford the National as well as Local Government Units enough time to continue utilizing appropriated funds in their disaster preparedness and response efforts to contain the spread of COVID-19 and to provide basic services to disaster affected population;

WHEREAS, RA 10121 or the DRRM Act of 2010 provides that the LDRRM Council, upon the recommendation of the LDRRM Office and the approval of the Sanggunian, may transfer funds to support other essential risk reduction activities;

WHEREAS, the City Disaster Risk Reduction & Management Council (CDRRMC) issued Resolution No. 08, Series of 2020, realigning the aforesaid amount from the LDRRM Fund Continuing Capital Outlay to support the city's ongoing COVID-19 Response Operations;

WHEREAS, the request was referred to the Offices of the City Budget Officer, City Accountant, and the City Treasurer for appropriate recommendations as to the funding source thereof and in this respect LBP No. 8 and LBP No. 9, herein attached as Annex "A" and "B" respectively, were subsequently issued by the concerned offices certifying therein that the amount of FIFTEEN MILLION FIVE HUNDRED THOUSAND PHILIPPINE PESOS (PHP15,500,000.00) is deemed available for the aforementioned purpose from the 70%, LDRRM Funds, to wit;

RESOLVED, AS IT IS HEREBY RESOLVED, to enact:

APPROPRIATION ORDINANCE NO. 026
(Series of 2020)

AN ORDINANCE REALIGNING FROM THE CITY'S CONTINUING APPROPRIATION OF THE 70% OF LOCAL DISASTER RISK REDUCTION MANAGEMENT (LDRRM) FUND IN THE AMOUNT OF FIFTEEN MILLION FIVE HUNDRED THOUSAND PHILIPPINE PESOS (PHP15,500,000.00) AND APPROPRIATING THE SAME FOR SUPPORT TO THE CITY'S ONGOING COVID-19 RESPONSE OPERATIONS.

SECTION 1. CY 2020 GENERAL FUND SUPPLEMENTAL BUDGET. The total amount of FIFTEEN MILLION FIVE HUNDRED THOUSAND PHILIPPINE PESOS (PHP15,500,000.00) is hereby realigned and appropriated to support the city's ongoing COVID-19 Response operations chargeable against the continuing appropriation for the 70% of Local Disaster Risk Reduction Management (LDRRM) Fund, this city.

SECTION 2. EFFECTIVITY. This Appropriation Ordinance shall take effect immediately upon its approval.


RESOLVED, FURTHER, that sufficient copies of this Appropriation Ordinance, together with all supporting documents thereof, be submitted to the Honorable Secretary of Department of Budget and Management, Manila, through the City Budget Officer of Ormoc and the Regional Director, Department of Budget & Management, Tacloban City, for review purposes;

ENACTED, November 10, 2020.

RESOLVED, FURTHERMORE, to furnish copies of this Appropriation Ordinance, one each to the City Mayor Richard I. Gomez; the City Administrator, Mr. Vincent L. Emnas; the City Legal Officer, Atty. Josephine M. Romero; the City Budget Officer; the City Accountant; the City Treasurer; the City Auditor; CDRMO; the City Local Government Operations Officer, DILG; and other offices concerned;

CARRIED by Eleven (11) Affirmative Votes. SP Member Vincent L. Rama encountered technical problem with his internet connection during the voting.



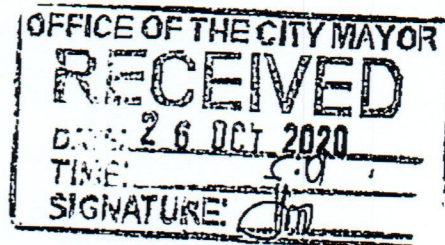


