


PREFATORY STATEMENT

WHEREAS, the Sangguniang Panlungsod was in receipt of an urgent Endorsement Letter from the City Mayor's Office dated March 1, 2021, respectfully requesting for a Supplemental Appropriation in the total amount of SIX MILLION PHILIPPINE PESOS (PHP6,000,000.00) for the operational expenses for the conduct of plebiscite/referendum relative to the merging of barangays;

WHEREAS, the Local Government Code (LGC) of 1991 under Section 384 provides that the Barangay, as the basic political unit, serves as the primary planning and implementing unit of government policies, plans, programs, projects, and activities in the community and as a forum wherein the collective views of the people may be expressed, crystalized and considered, and where disputes may be amicably settled;

WHEREAS, the current realities in our district barangays indicate that the challenges we are experiencing- the inability to deliver basic public services in an efficient and most responsive manner and the lack of necessary facilities for us to carry out an effective government are due mainly to the limited area and the less than standard population that we have;

WHEREAS, this Sanggunian enacted Ordinance No. 052, Series of 2021, entitled: "AN ORDINANCE MERGING BARANGAY DISTRICT 1 TO BARANGAY DISTRICT 28 AND RENAMING BARANGAY DISTRICT 29 IN ORMOC CITY AND APPROPRIATING FUNDS THEREFORE"; providing that the twenty-nine (29) District Barangays of Ormoc City are hereby redistricted and reduced to only four (4) barangays basing on the recommendation that will address the concerns and issues pertaining to the capacity of the aforementioned barangays to deliver the basic services of its constituents;

WHEREAS, Section 4 of the Ordinance stated that the merger of the District Barangays shall be subject to the approval by a majority of the votes cast in a plebiscite to be conducted by the COMELEC in the District Barangays directly affected within One Hundred Twenty (120) days from effectivity of the ordinance;

WHEREAS, Section 9 of the same provides that the cost of the plebiscite shall be taken out of the city's annual budget, corresponding to the year of its implementation and under the current fiscal year appropriations;

WHEREAS, the request was referred to the Offices of the City Budget Officer, City Accountant, and the City Treasurer for appropriate recommendations as to the funding source thereof and in this respect LBP No. 8 and LBP No. 9, herein attached as Annex "A" and "B" respectively, were consecutively issued by the concerned offices certifying therein that the amount of SIX MILLION PHILIPPINE PESOS (PHP6,000,000.00) is deemed available for the aforementioned purpose to be taken from the City's Unappropriated Surplus - 2020, to wit:

WHEREAS, this Sanggunian finds that the endorsed request for the supplemental appropriation is justified, reasonable and meritorious as it will augment the efficacy and effectiveness in the rendering of the services to the public for the benefit of the constituents of the City of Ormoc, and the general public;

WHEREFORE, FOREGOING PREMISES CONSIDERED, on motion of SP Member Peter M. Rodriguez, Chairman, Committee on Finance & Appropriation, severally seconded by SP Members Esteban V. Laurente, Gregorio G. Yrastorza III, Joan Marbie C. Simbajon, Jasper M. Lucero and Nolito M. Quilang; be it

RESOLVED, to enact:

APPROPRIATION ORDINANCE NO. 005
(Series of 2021)

AN ORDINANCE APPROPRIATING THE
UNAPPROPRIATED SURPLUS - 2020 IN THE TOTAL
AMOUNT OF SIX MILLION PHILIPPINE PESOS
(PHP6,000,000.00) UNDER CMO - OTHER MOOE FOR
THE OPERATIONAL EXPENSES FOR THE CONDUCT
OF THE PLEBISCITE/REFERENDUM RELATIVE TO
THE MERGING OF BARANGAYS.

BE IT ENACTED, by the Fifteenth Sangguniang Panlungsod of Ormoc in Regular Session assembled, that:

SECTION 1. CY 2021 GENERAL FUND SUPPLEMENTAL BUDGET. The total sum of SIX MILLION PHILIPPINE PESOS (PHP6,000,000.00) to be taken from the City's Unappropriated Surplus of 2020 is hereby appropriated for the operational expenses for the conduct of the plebiscite/referendum relative to the merging of barangays.

SECTION 2. EFFECTIVITY. This Appropriation Ordinance shall take effect immediately upon its approval.


RESOLVED, FURTHER, that sufficient copies of this Appropriation Ordinance, together with all supporting documents thereof, be submitted to the Regional Director, Department of Budget & Management, Tacloban City, for review purposes;

ENACTED, March 02, 2021.

RESOLVED, FURTHERMORE, to furnish copies of this Appropriation Ordinance, one each to the City Mayor Richard I. Gomez; the City Administrator, Mr. Vincent L. Emnas; the City Legal Officer; the City Budget Officer; the City Accountant; the City Treasurer; the City Auditor; the CPDO; the Chapter President, Liga ng mga Barangay ng Ormoc; the City Local Government Operations Officer, DILG; and other offices concerned;

CARRIED by Eight (8) Affirmative Votes. SP Member Vincent L. Rama encountered technical problem with his internet connection during the voting.






