PREFATORY STATEMENT

WHEREAS, the Sangguniang Panlungsod received an endorsement letter from the City Mayor's Office (CMO) dated June 25, 2021 requesting for a supplemental appropriation in the amount of Nine Million One Hundred Thousand Philippine Pesos (Php9,100,000.00) for the purchase of generator set and the supply and installation of elevator at Ormoc City Museum;

WHEREAS, the cost of the supply and installation of elevator amounts to Six Million Six Hundred Thousand Philippine Pesos (Php 6,600,000.00) intended not only for lifting passengers but also to safely move exhibits while the proposed generator set amounts to Two Million Five Hundred Thousand Philippine Pesos (Php2,500,000.00) with a rated output power of 120 KVA or 96 KW;

WHEREAS, the request was referred to the Offices of the City Budget Officer, City Accountant, and the City Treasurer for appropriate recommendations as to the funding source thereof and in this respect a new LBP Form No. 8 and LBP Form No. 9 were consecutively issued by the concerned offices certifying therein that the of Nine Million One Hundred Thousand Philippine Pesos (Php9,100,000.00) is deemed available for the aforementioned purpose to be taken from the CY 2020 Unappropriated Surplus, herein attached as Annex "A" and "B" respectively;

WHEREAS, this Sanggunian finds the supplemental request justified and deemed reasonable and meritorious and for the efficient execution of business operations and transactions of the aforementioned office hence, most deserving of prompt favorable action;

APPROPRIATION ORDINANCE NO. 019 (Series of 2021)
