### PREFATORY STATEMENT

WHEREAS, the Sangguniang Panlungsod received an endorsement letter from the City Mayor's Office (CMO) dated August 19, 2021 requesting for a supplemental appropriation in the total amount of Thirteen Million Nine Hundred Sixty Thousand Philippine Pesos (Php13,960,000.00) for Ormoc Waterworks System Administration's (ORWASA) Improvements and Development of Ormoc City Water System-Pipeline Installation Level III at Brgy. Licuma and CEO's Rehabilitation of Footbridge at Sitio Esmaela, Brgy. San Jose, Construction of Public Buildings and Facilities-Construction of Police Building (Phase 1) at Brgy. Dolores, and Construction/Enhancement of Ormoc City DRRM Operations Center and Substation-Construction Of Boat Storage (Phase II) at Brgy. Alegria, Ormoc City;

WHEREAS, the request was referred to the Offices of the City Budget Officer, City Accountant, and the City Treasurer for appropriate recommendations as to the funding source thereof and in this respect LBP Form No. 8 and LBP Form No. 9 were consecutively issued by the concerned offices certifying therein that the amount of Thirteen Million Nine Hundred Sixty Thousand Philippine Pesos (Php13,960,000.00) is deemed available for the aforementioned purpose, herein attached as Annex "A" and "B" respectively;

WHEREAS, ORWASA's improvements and development of Ormoc City Water System-Pipeline Installation Level III at Brgy. Licuma, Ormoc City amounted to Php1,600,000.00;

WHEREAS, the Local Finance Committee during the committee meeting recommended that the rehabilitation project of the footbridge at Sitio Esmaela, Brgy. San Jose, Ormoc City should be a construction project since majority of the bridge will be removed;

WHEREAS, the Construction of Public Buildings and Facilities-Construction of Police Building (Phase 1) at Brgy. Dolores is deferred since the lot it will be built on is not government owned and the usufruct agreement between the LGU and its owner is still subject for further review;

WHEREAS, this Sanggunian finds the request for supplemental appropriation justified and deemed reasonable and meritorious and for the best interest of the development of Ormoc City, hence, most deserving of prompt favorable action;
