PREFATORY STATEMENT

WHEREAS, the 15th Sangguniang Panlungsod was in receipt of the FY 2022 Executive Budget of the City of Ormoc for consideration for both the General Fund and Operations of the Local Economic Enterprises (LEEs) in the total amount of TWO BILLION TWO HUNDRED TWENTY-EIGHT MILLION SIX HUNDRED ONE THOUSAND ONE HUNDRED TWENTY-FOUR PHILIPPINE PESOS (PHP2, 228,601,124,00);

WHEREAS, the FY 2022 Executive Budget provides for the priority programs and projects of the city as per approved FY 2022 Annual Investment Program (AIP) and its formulation is anchored on the goal of initiating changes that respond to the clamor for a more participatory form of government, increased transparency and public accountability in government operations, and improved delivery of public service;

WHEREAS, the proposed FY 2022 Executive Budget shall be sourced out from both national and local sources which are allocated in accordance with the general guidelines set forth under Local Budget Memorandum No. 82 and 82-A, summarized as follows:

WHEREAS, through the whole budget phase, an orientation on AIP Preparation, a Budget Forum, and one-on-one budget consultations were conducted among the different departments, offices, and stakeholders, including the Civil Society Organizations (CSOs) to ensure the inclusion of their proposed programs, projects, and activities that would benefit the constituents of Ormoc City the most;

WHEREAS, the FY 2022 Executive Budget takes into consideration the priority needs and services of all sectors of the Ormocanon community, with sizeable increase in budget allocation for most frontline departments/offices attributed to the absorption of devolved functions pursuant to Executive Order (EO) No. 138 dated June 1, 2021, and clearly define the present administration's zeal and determination to move the city forward anchored on the following goals and objectives, to wit:

- Agricultural Productivity, Food Production and Fisheries;
- Health, Sanitation and Social Welfare;
- Education;
- Trade and Investments;
- · Good Governance;
- Revenue Generation;
- Environmental Preservation;
- · Tourism and;
- Traffic Management;

RESOLVED, to enact:

APPROPRIATION ORDINANCE NO. 01 (Series of 2022)

ORDINANCE AUTHORIZING THE ANNUAL BUDGET OF ORMOC CITY FOR FISCAL YEAR 2022 IN THE TOTAL AMOUNT OF TWO BILLION TWO HUNDRED HUNDRED TWENTY-EIGHT **MILLION** SIX **THOUSAND** ONE HUNDRED TWENTY-FOUR (PHP2,228,601,124.00) PHILIPPINE PESOS COVERING THE VARIOUS EXPENDITURES FOR THE OPERATION OF THE ORMOC CITY GOVERNMENT FOR FISCAL YEAR 2022, AND APPROPRIATING THE NECESSARY FUNDS FOR THE PURPOSE.

BE IT ENACTED, by the 15th Sanggunian Sangguniang Panlungsod ng Ormoc, That:

SECTION 1. The Annual Budget of the City of Ormoc for Fiscal Year 2022 in the total amount of **TWO BILLION TWO HUNDRED TWENTY-EIGHT MILLION SIX HUNDRED ONE THOUSAND ONE HUNDRED TWENTY-FOUR PHILIPPINE PESOS (PHP2,228,601,124.00) covering the various expenditures for the operation of Ormoc City for the year 2022 is hereby approved.**

The Local Expenditures Program (LEP) from January 1 to December 31, 2022 consisting of the following are incorporated herein and made integral part of this Ordinance:

- 1. Budget of Expenditures and Sources of Financing; and
- 2. Personnel Schedule by Departments, Offices and Units

SECTION 2. SOURCE OF FUNDS. The source of funds for the FY 2022 Annual Budget in the total amount of TWO BILLION TWO HUNDRED TWENTY-EIGHT MILLION SIX HUNDRED ONE THOUSAND ONE HUNDRED TWENTY-FOUR PHILIPPINE PESOS (PHP2,228,601,124.00) shall be as follows:

SECTION 3. <u>USE OF FUNDS.</u> The amount of TWO BILLION TWO HUNDRED TWENTY-EIGHT MILLION SIX HUNDRED ONE THOUSAND ONE HUNDRED TWENTY-FOUR PHILIPPINE PESOS (PHP2,228,601,124 00) is hereby appropriated for the expenses of the City of Ormoc as identified in the attached 2022 Budget of Expenditures and Sources of Financing, for the period covering January 1, 2022 to December 31, 2022;

SECTION 4. USE OF SAVINGS AND AUGMENTATIONS. In accordance with Section 336 of Republic Act 7160, the Local Government Code of 1991, the Local Chief Executive and the Presiding Officer of the Sanggunian are authorized to augment any item in the approved annual budget for their respective offices from savings in other items within the same expense class of their respective appropriations.

SECTION 5. SEPARABILITY CLAUSE. If, for any reason, any Section or provision of this Appropriation Ordinance is disallowed in Budget Review or declared invalid by proper authorities, other Sections or provisions hereof that are not affected thereby shall continue to be in full force and effect.

SECTION 6. EFFECTIVITY. The Provisions of this Appropriation Ordinance shall take effect on January 1, 2022, subject however, to the compliance of the posting and publication requirements as provided in the Local Government Code of 1991.
