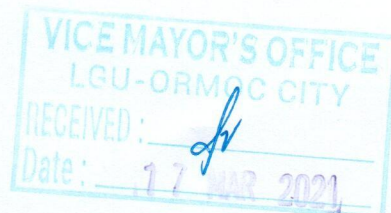
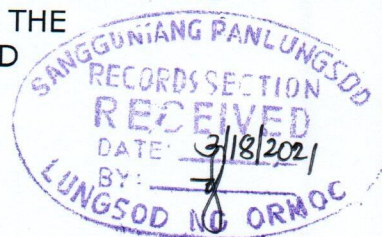

EXPLANATORY STATEMENT

WHEREAS, Ordinance No. 054, Series of 2021, otherwise known as "AN ORDINANCE CREATING FOUR (4) ADDITIONAL POSITIONS OF ENVIRONMENTAL MANAGEMENT SPECIALIST I FOR THE CITY ENVIRONMENT AND NATURAL RESOURCES OFFICE (ENRO) AND APPROPRIATING NECESSARY FUNDS THEREOF", was signed into law last February 10, 2021;

WHEREAS, the Human Resource Management Office sent a letter on February 24, 2021 raising a concern that in the aforesaid Ordinance, it was observed that on Section 2. Abolition of Existing Positions, the position Administrative Aide III (Ticket Checker), Item Number 331, reflected an item number that is inconsistent with what is indicated in the actual Plantilla of Personnel. And based on this year's Plantilla of Personnel, TICKET CHECKER, has Item Number 674;

WHEREAS, to address said concern and aide in the speedy progress, this amendment be enacted;

NOW, THEREFORE, on joint motion of SP Member Jasper M. Lucero, Chairman, Committee on Good Government and Oversight, and SP Member Lalaine A. Marcos, Chairman, Committee on Environment, Natural Resources & Energy Conservation, severally seconded by SP Members Roiland H. Villasencio, Tomas R. Serafica, Peter M. Rodriguez, Esteban V. Laurente, Joan Marbie C. Simbajon and Vincent L. Rama; be it

RESOLVED, to enact:

ORDINANCE NO. 057
(Series of 2021)

AN ORDINANCE AMENDING SECTION 2 OF ORDINANCE NO. 054, SERIES OF 2021, OTHERWISE KNOWN AS "AN ORDINANCE CREATING FOUR (4) ADDITIONAL POSITIONS OF ENVIRONMENTAL MANAGEMENT SPECIALIST I FOR THE CITY ENVIRONMENT AND NATURAL RESOURCES OFFICE (ENRO) AND APPROPRIATING NECESSARY FUNDS THEREOF."

BE IT ORDAINED by the 15th Sangguniang Panlungsod of Ormoc City, that:

SECTION 1. AMENDMENT– Section 2 of Ordinance No. 054 is hereby amended to read as follows:

"SECTION 2. ABOLITION OF EXISTING POSITIONS– The following vacant/unfilled positions shall be abolished to give way to the creation of new positions enumerated under Section 1 of this ordinance:

SECTION 2. REPEALING CLAUSE– Any provision of ordinances, rule and regulations and/or parts thereof inconsistent with the provisions of this ordinance are hereby modified, amended, and/or repealed accordingly.

SECTION 3. SEPARABILITY CLAUSE– Should any provision of this Ordinance be declared unconstitutional or invalid by any court of competent jurisdiction, the provisions that are not affected thereby shall continue to be in full force and effect.


SECTION 4. EFFECTIVITY– This Ordinance shall take effect immediately upon approval and after compliance with the requirements of Republic Act No. 7160, otherwise known as the Local Government Code of 1991.

CARRIED by Eleven (11) Affirmative Votes, SP Member Nolito M. Quilang left the on-line video conference for an important commitment with permission.


