PREFATORY STATEMENT

The City of Ormoc had enacted on June 27, 2002, Ordinance No. 092, Series of 2002, otherwise known as the, "2002 Comprehensive Zoning Ordinance of Ormoc City."

Said Zoning Ordinance was passed to put in place measures to regulate the activities relative to the use of lands, buildings, and structures within the City's jurisdiction in order to promote the general welfare of its inhabitants and address the need to create balanced distribution of social and economic development and environmental integrity.

In fact, the City Government continues to update its policies and regulations to be attuned to current local situations, and the changing needs of the times in order to remain competitive as the City continually progresses into a center for economic activity in the Region.

Said Ordinance, however, was found upon actual application by the concerned offices that it had lack certain important provisions – the imposition of the period within which grants or denials of Locational Clearance applications by the Zoning Administrator of the City Planning Development Office (CPDO) or this Sanggunian, as the case maybe, maybe appealed by an interested party before an appellate body the Ordinance had created - the Local Zoning Board of Adjustment and Appeals (LZBAA).

Hence, this amendatory ordinance.

RESOLVED, AS IT IS HEREBY RESOLVED, to enact:

ORDINANCE NO. 058 (Series of 2021)

AN ORDINANCE FURTHER AMENDING ORDINANCE NO. 092 SERIES OF 2002, OTHERWISE KNOWN AS THE "2002 COMPREHENSIVE ZONING ORDINANCE OF ORMOC CITY" BY ADDING CERTAIN PROVISIONS THEREON.

Be it enacted by the Fifteenth Sangguniang Panlungsod in Regular Session assembled, that:

SECTION 1. Section 56 (B) of Ordinance No. 092 Series of 2002, otherwise known as the "2002 Comprehensive Zoning Ordinance of Ormoc City" as amended by Ordinance No. 072, Series of 2018 shall now read as follows:

"B. Assess or review appeals on grant or denial by any interested party of Locational Clearance or Zoning Certificate applications. Such appeals from the decisions of the Sangguniang Panlungsod, in cases of Subdivision Projects, and the Zoning Administrator, in other cases, shall be appealable to the Local Zoning Board of Adjustments and Appeals (LZBAA) within Fifteen (15) days from receipt of the decision by the appellant or applicant. Otherwise, the same shall become final and executory."

SECTION 2. If, for any reason, any provision of this Ordinance is declared to be unconstitutional or invalid, the other sections or provisions hereof which are not affected shall continue to be in full force and effect.

SECTION 3. All existing ordinances and parts hereof which are inconsistent with the provisions of this Ordinance are hereby deemed repealed, amended, or modified accordingly.
