PREFATORY STATEMENT

"Ignorance of the law excuses no one from compliance therewith", a legal principle commonly used where the people cannot simply escape liability by merely invoking they are unaware of the law. However, imagine a society where its own legislators and law enforcers know that there is in fact a violation of a law but cannot specifically point out what law has been violated or have identified a particular law but, unaware that the law has already become obsolete. To reduce this confusion and disarray both from the public and the government, there must be a system of collecting, inventorying, and classifying the legislation by subject - **A Codification of General Ordinances.** This significantly improves the capability of the City to consolidate reforms and enforce the Ordinances and for the public's easier accessibility.

Since the founding of the City of Ormoc, a great number of Ordinances have been enacted by the Members of the Sangguniang Panlungsod. For several years, the Sanggunian wanted to codify the thousands of Ordinances in their record for an easier and quick reference. Since then, there was a major initiative of classifying these Ordinances into various categories. In 2003, the Code of General Ordinances was finally enacted through the efforts of the late City Councilor Nepomuceno P. Aparis I. Its last revision and updates was finished in 2007. However, in the following years, no revisions were being made.

In order to continue the good practice of compiling the various Ordinances, a new and updated version of the Code must be enacted. From the previous codification of a single book. This Sanggunian has prepared three (3) Books classified into multiple categories, namely: **BOOK I - ECONOMIC GOVERNANCE, BOOK II - SOCIAL AND ENVIRONMENTAL GOVERNANCE, and BOOK III - ADMINISTRATIVE GOVERNANCE, INFRASTRUCTURE AND UTILITIES;**

With this, no longer would the general populace invoke that they do not know they have violated a law nor the legislators would insist the usefulness of an already obsolete law. True to the legal principle where "Ignorance of the law excuses no one from compliance therewith".

RESOLVED, to enact:

**ORDINANCE NO. 063
(Series of 2021)**

**AN ORDINANCE ORDAINING THE CODIFICATION OF
GENERAL ORDINANCES OF THE CITY OF ORMOC.**

BE IT ORDAINED by this 15th Sangguniang Panlungsod ng Ormoc in its Regular Session assembled, That:

**CHAPTER I
INTRODUCTORY PROVISIONS**

SECTION 1. TITLE – This Code shall be known and referred to as the **CODE OF GENERAL ORDINANCES OF ORMOC CITY.**

SECTION 2. RELATION TO PRIOR ORDINANCES – The provisions of this Code which are substantially the same as existing ordinances relating to the same subject matter shall be construed as restatements and not as new enactments, unless otherwise explicitly modified herein.

SECTION 3. EXISTING RIGHTS – Vested rights on the date of the effectivity of this Code arising out of contracts or any other source of obligation, shall be governed by the original terms and provisions of said contracts or the law or ordinance in force at the time such rights became vested and in no case shall this Code infringe on them.

SECTION 4. REFERENCE TO CODE – Whenever reference is made to any provision of this Code, the reference applies to all its amendments and additions hereinafter made.

**CHAPTER II
DEFINITIONS**

SECTION 1. COVERAGE – The Definition of Terms and Phrases embodied in this Chapter shall govern the interpretation and meaning of these items and phrases as found in the specific sections and chapters.



EFFECTIVITY CLAUSE**






