**PREFATORY STATEMENT**

WHEREAS, the 15th Sangguniang Panlungsod of Ormoc received a copy of the Ormoc City Sports Commission Resolution No. 01, Series of 2021 urging the Sangguniang Panlungsod to amend the amount of incentives granted to the winning athletes as embodied in City Ordinance No. 014, Series of 2019, entitled: "AN ORDINANCE AMENDING ORDINANCE NO. 056, S. 2018, ENTITLED: "AN ORDINANCE GRANTING CASH INCENTIVES TO ATHLETES AND COACHES IN ORMOC CITY INDIVIDUALS, PAIRED OR GROUPS WHO EXCELLED IN SPORTS COMPETITIONS AND APPROPRIATING FUNDS THEREFOR".

WHEREAS, the Ormoc City Sports Commission believes that the said increase of incentives is proper since most of our Ormocanon Athletes have been competing and winning in different events both international and national;

WHEREAS, the Ormoc City Sports Commission further stressed that the said increase of the same will attract and motivate potential Ormocanon Athletes to excel in their respective field of sports;

WHEREAS, City Ordinance No. 056, Series of 2018 and City Ordinance No. 014, Series of 2019 was passed by the 14th and 15th Sangguniang Panlungsod, respectively, which the Ormoc City Sports Commission was not formally created yet;

WHEREAS, the abovementioned ordinance only grants incentives to winning athletes in both national and international sports competitions sans regional sports competitions;



WHEREAS, during the Committee Meeting conducted on April 29, 2021, it was found out that the abovestated ordinances shall be repealed and revised thru the passage of an ordinance in response to the mandate of the Ormoc City Sports Commission;

WHEREAS, this body finds it appropriate to pass this revised ordinance by repealing the two existing ordinances;

WHEREFORE, on joint motion of SP Member Joan Marbie C. Simbajon, Chairman, Committee on Youth and Sports Development and SP Member Peter M. Rodriguez, Chairman, Committee on Finance and Appropriation, duly seconded by SP Member Roiland H. Villasencio; be it

RESOLVED, to enact:

**ORDINANCE NO. 064  
(Series of 2021)**

**AN ORDINANCE REVISING THE GUIDELINES ON GRANTING OF INCENTIVES TO THE WINNING ORMOCANON ATHLETES AND COACHES THEREBY REPEALING ORDINANCE NO. 056, SERIES OF 2018 AND ORDINANCE NO. 014, SERIES OF 2019.**

BE IT ENACTED by the 15th Sangguniang Panlungsod in Regular Session assembled that:

**SECTION 1. TITLE.** This local legislation shall be known as the **"Revised Incentives to the Winning Ormocanon Athletes and Coaches Ordinance"**.

**SECTION 2. DECLARATION OF POLICY.** It is the policy of the City Government of Ormoc to extend financial incentives to deserving athletes and coaches for bringing honor to the City in various legitimate competitions in the field of sports pursuant to Section 7.3 of Ordinance No. 018, Series of 2020, otherwise known as the "Ormoc City Sports Commission Ordinance".

**SECTION 3. DEFINITION OF TERMS.**

- a. Athlete- refers to a person trained to compete in sports involving physical strength or mental agility, speed and endurance. He/she must be a bonafide resident of the City of Ormoc for at least one (1) year and already part of the Ormocanon Pool Athletes of his/her organization must be duly recognized as an active sports organization in the city by the Commission. It includes Persons With Disabilities (PWD) Athletes.
- b. Coach – refers to an expert who trains a person or team of people in a particular sport. He or she must be a Filipino Citizen and duly accredited Coach of a Sports Organization whereby the latter must be a registered Organization by the Commission.
- c. Commission – refers to Ormoc City Sports Commission.
- d. Grantee – refers to an Ormocanon Winner(s) together with his/her/their Coach who is/are qualified to receive the incentive granted by this ordinance.



- e. Individual Event – refers to an athlete who participates in sports which require a single player.
- f. Team Event – refers to sports which require two or more players in a team to compete against another team.
- g. Office – refers to Ormoc City Sports Office.
- h. Sports Competition – refer to various sports activities that are accredited and/or sanctioned by the Commission, Philippine Sports Commission, Southeast Asian Games Federation, Olympic Council of Asia, International Olympic Committee, ASEAN Parasports Federation, Asian Paralympic Committee, International Paralympics Committee which includes among others:

**I. REGIONAL SPORTS COMPETITION**

- 1.) PRISAA - Regional
- 2.) EVRAA
- 3.) SCUAA – Regional

**II. NATIONAL SPORTS COMPETITION**

- 1) Paralong Pambansa
- 2) Batang Pinoy
- 3) Philippine National Games

**III. INTERNATIONAL SPORTS COMPETITION**

- 1) Olympic Games (Summer and Winter)
- 2) SEA Games/ASEAN Para Games
- 3) Asian Games/Asian Para Games
- 4) Paralympics Games
- 5) World Championships sponsored by different International Sports Associations (ISAs)

**SECTION 4. REQUIREMENT OF GRANTEES** – To qualify as grantee(s), athletes or coaches must fulfill the following requirements:

**A. ATHLETES:**

- 1. Submission of Letter of Intent or Invitation (indicating that the grantee/s represent/s Ormoc City) from the accredited organization to the athlete or team except for annual regular competitions (e.g. Batang Pinoy, EVRAA, Palarong Pambansa, Philippine National Games) duly processed and certified by the Commission before the event;
- 2. Be able to submit the original and/or certified true copy of certifications and appropriate documentations PROVIDED that he/she won either gold, silver, or bronze medals during the said event;
- 3. Resolution by the Commission granting such incentives; and
- 4. To claim the incentives, the appropriate documents must be submitted to the Office.

**B. COACHES:**

Coaches of winning athletes shall also be entitled to cash incentives if they have personally trained and rendered service to the athletes or teams at least six (6) months prior to the international competition. A certification shall be issued by the commission with regards to the duration of the training.

The incentives for the coaches shall be equivalent to fifty percent (50%) of the cash incentives for gold, silver and bronze medalist. In case of more than one (1) coach, the cash incentives shall be divided among themselves.

**SECTION 5. AMOUNT OF INCENTIVE:**

A. For individual or team sports competitions for the regional, national or international levels of competitions, qualified grantees shall be entitled of the following cash incentives:

**I. REGIONAL**

Individual

- \*Gold - Php 5,000.00
- \*Silver - Php 3,000.00
- \*Bronze - Php 2,000.00

Team

- \*Gold - Php 30,000.00
- \*Silver - Php 20,000.00
- \*Bronze - Php 10,000.00

**II. NATIONAL**

Individual

- \*Gold - Php 50,000.00
- \*Silver - Php 30,000.00
- \*Bronze - Php 20,000.00

Team

- \*Gold - Php 100,000.00
- \*Silver - Php 50,000.00
- \*Bronze - Php 40,000.00

**III. INTERNATIONAL**

**a. SEA GAMES and other International Events**

Individual

- \*Gold - Php 100,000.00
- \*Silver - Php 75,000.00
- \*Bronze - Php 50,000.00

Team

- \*Gold - Php 200,000.00
- \*Silver - Php 150,000.00
- \*Bronze - Php 100,000.00

**b. ASIAN GAMES**

Individual

- \*Gold - Php 250,000.00
- \*Silver - Php 200,000.00
- \*Bronze - Php 150,000.00



<u>Team</u>	
*Gold	- Php 500,000.00
*Silver	- Php 400,000.00
*Bronze	- Php 300,000.00

c. OLYMPICS

<u>Individual</u>	
*Gold	- Php 500,000.00
*Silver	- Php 300,000.00
*Bronze	- Php 200,000.00

<u>Team</u>	
*Gold	- Php 1,000,000.00
*Silver	- Php 700,000.00
*Bronze	- Php 500,000.00

For competitions with less than five (5) participants per team, the individual members of the team shall receive the same cash incentives for individual medal winners provided only members present during the actual competition shall be entitled to such incentives.

Only the qualified grantee duly compliant under Section 4 of this Ordinance shall be entitled to receive the financial incentive. The grant shall be non-transferable.

**SECTION 6. LIMITATION** – In case of multiple medals won in a single competition and event, the grantee shall be entitled to a maximum of five (5) incentives per competition subject to the availability of funds.

**SECTION 7. FUNDS FOR THE PROGRAM.** To carry out of the provisions of this Ordinance, the necessary amount shall be taken from the annual appropriation of the City subject to pertinent and appropriate government accounting and auditing rules and regulations.

**SECTION 8. IMPLEMENTING RULES AND REGULATIONS** – Within sixty (60) days from the effectivity of this ordinance, the Commission shall formulate the Implementing Rules and Regulations (IRR) necessary to carry out the provisions of this Ordinance.

**SECTION 9. REPEALING CLAUSE** – All ordinances, and other rules and regulations or parts thereof which are inconsistent with this ordinance are hereby deemed repealed or modified accordingly.

**SECTION 10. EFFECTIVITY** – This ordinance shall take effect immediately upon its approval and after compliance with publication and posting requirements pursuant to the relevant provisions of the Local Government Code of 1991.


