ORDINANCE NO. 10

On motion of Vice-Mayer Porfirio Ayuyao, seconded by
Councilor Paster C. Tan,

BE IT RESOLVED, to adopt an "ORDINANCE AMENDING (1)
THE RESOLUTORY CLAUSE, (2) SECTION I, AND (3) PARAGRAPH 1 OF
SECTION II OF ORDINANCE NO. 8, CS, IN ORDER TO BE READ AS FOL-
EWS:"

BE IT ENACTED by the authority of the Municipal Council
of Ormoc, Leyte, that:

RESOLUTORY CLAUSE:- "AN ORDINANCE, FOR THE DURATION OF
THE EMERGENCY, PRESCRIBING RESTRICTION UPON SLAUGHTER OF LARGE
CATTLE AND IMPOSING GRADUATED SLAUGHTER FEES THEREFOR".

SECTION I.- This ordinance shall be known as the "RE-
GULATORY ORDINANCE ON LARGE CATTLE" and shall be enforced only
up to the end of the year 1946.

SECTION II.- The applicant for slaughter permit shall
cause his large cattle to be verified and examined for approval
or disapproval by the COMMITTEE ON THE SLAUGHTER OF LARGE CAT-
TLE created under Resolution No. 51, cs, as amended, of the Muni-
cipal Council of this Municipality.

SECTION III.- Any person, firm or corporation violat-
ing the provisions of this ordinance shall be punished by the
penalty provided for in section V of Ordinance No. 8, cs.

SECTION IV.- All previous ordinances in conflict with
this ordinance are hereby repealed.
