ORDINANCE NO. 14

On motion of Councilor Pastor C. Tan, seconded by

BE IT RESOLVED, to amend "ITEM 2 OF SECTION II OF  
ORDINANCE NO. 8, CS, IN ORDER TO READ AS FOLLOWS".

BE IT ORDAINED by the authority of the Municipal  
Council of this Municipality that:

SECTION I.- The applicant for slaughter permit shall  
be required to pay to the Municipal Treasurer of this Muni-  
cipality or his duly authorized representative for the tra-  
veling expenses of the Committee and for the slaughter fee  
under the following schedule:
