On motion of Vice-Mayor Perfirio Ayuyaø, seconded by Councilor Saturnino Villoria,

BE IT RESOLVED, to adopt an "ORDINANCE AMENDING ORDINANCE NO.1, CS, IN ORDER TO APPLY THE PROVISIONS THEREOF TO BOTH TEMPORARY AND PERMANENT STRUCTURES OR SHACKS, AND OTHER PURPOSES, AND PRESCEIBING PENALTIES THEREFOR".

BE IT ORDAINED by the Municipal Council of Ormoc, Leyte Philippines, that:

SECTION 1.- This Ordinance shall be known as "THE REGULATORY ORDINANCE ON STRUCTURES OR SHACKS, AND OTHER PURPOSES".

SECTION 2.- Hereafter, to promote the general health, welfare and comfort of the people living in this municipality, no structure for living purposes, whether roofed with cogon, nipa, or otherwise, shall be built without complying with the following conditions:

(a) If along the road, the structures or shack shall be at least fifteen feet (or 4-1/2 meters) therefrom and the neighboring shacks;

(b) Structures or shacks in the interior shall be, at least, fifteen feet from its neighbors measured from their nearest points;

(c) Every structure or shack shall be provided with a sanitary toilet appreved by the President of the Sanitary Division of this municipality;

(d) The toilet and the kitchen shall be behind the structure or shack, but where the toilet is separate, same

shall be fifteen feet from any neighboring shack or toilet;

(e) Toilets shall be always covered, whether or not they form a part of the shacks.

SECTION 3.- Any person who desires to construct any structure or shack in the Poblacion of Ormoc, Leyte, shall first secure permit to do so, either in person or in writing, from the office of the Municipal Mayer, and shall pay a permit fee to the office of the Municipal Treasurer with the following specifications:

For permanent structure .....	₱10.00
" temporary " .....	1.00

SECTION 4.- Any person violating any provision or provisions of this Ordinance shall be punished by imprisonment of not more than one month, or by a fine of not more than ₱200.00 or both, in discretion of the Court.

SECTION 5.- All previous ordinances or portions thereof in conflict ~~hath~~with are hereby repealed.

SECTION 6.- This ordinance shall take effect upon approval.
