## ORDINANCE NO.9

WHEREAS, it has come to the knowledge of our Municipal Officials that meat of large cattle slaughtered outside the limits of this Municipality is being sold herein for public consumption:

WHEREAS, those Municipal Officials are in a firm belief that, unless the owner of the meat has with him slaughter permit from the Municipal Treasurer, or his duly authorized representative, of the Municipality where the slaughter was performed, the animal slaughtered is a stelen one, or else sickly hence the meat is unfit for human consumption:

WHEREAS, the intention of the Municipal Council of this Municipality is to check up, or so stop, the stealing and illegal butchering of large cattle, and to protect the health of the inhabitants herein:

NOW, THEREFORE, ON MOTION of Vice-Mayor Porfirio Ayuyao, seconded by Councilor Restitute Cabiling,

BE IT RESOLVED, to adopt an "ORDINANCE, FOR THE DURATION OF THE EMERGENCY PERIOD, PROHIBITING THE ENTRY INTO AND SALE IN THIS MUNICIPALITY OF THE MEAT OF LARGE CATTLE SLAUGHTERED OUTSIDE THE LIMITS HEREOF".

BE IT ENACTED by the Muthority of the Municipal Council Ormoc, Leyte, that:

SECTION I. - This Ordinance shall be known as "THE PRO-HIBITORY ORDINANCE, FOR THE DURATION OF THE EMERGENCY PERIOD,

(Ordinance No.9, s-45, of the Mun. Council of Ormoc) PAGE TWO ON THE ENTRY INTO AND SALE IN THIS MUNICIPALITY OF THE MEAT OF LARGE CATTLE SLAUGHTERED OUTSIDE THE LIMITS HEREOF". SECTION II .- Hereafter, it shall be unlawful for any person, firm or corporation to bring into this Municipality from outside the limits hereof meat of large cattle for public consumption without the necessary slaughter permit from the Municipal Treasurer, or his duly authorized representative. of the Municipality where the slaughter was performed. SECTION III .- Any person, firm or corporation violati ing the provision of this Ordinance shall be punished by a fine of not hess than \$10.00 nor more than \$200.00, or by imprisonment of not less than 5 days nor more than 2 months, or both, at the discretion of the Court. SECTION IV .- All previous ordinances in conflict with this ordinance are hereby repealed. SECTION V .- This Ordinance shall take effect immediately upon its approval. UNANIMOUSLY APPROVED.
