ORDINANCE NO. 4

On motion of Councilor Andres Masias, seconded by
Councilor Isidro Tizon,

BE IT RESOLVED, to adopt "AN ORDINANCE PROVIDING
FOR THE SCHEDULE OF RATES OR TARIFF FOR PASSENGER TARTA-
NILLAS, AND PRESCRIBING PENALTIES FOR NON-COMPLIANCE THERE-
WITH".

BE IT ORDAINED by the Municipal Board of the City
of Ormoc and by authority of the same,

SECTION 1. The following schedule of rates or tariff
shall be observed by all persons or entities operating or run-
ning tartanillas for public use, viz:

WITHIN DOWNTOWN LIMITS

PASSENGERS:

₱0.10 for one passenger only
.15 for two passengers
.20 for three passengers
.25 for four passengers

CARGOES:

₱0.05 a cavan of cereal or any other load of
more than 20 kilos but not exceeding 60 kilos weight,
and ₱0.05 for every additional weight of not exceed-
ing 60 kilos.

Any cargo of less than a cavan or weighing
less than 20 kilos shall be free of charge.

BEYOND DOWNTOWN LIMITS

Rate for fare or freight shall be subject to any agreement which may be entered into between the passenger or passengers and the Cochero or Tartanilla Driver.

SECTION 2.- For purposes of this ordinance, downtown limits shall be construed as the area of Ormoc City bounded by the seashore, Alegria Bridge, Cogon Combado Crossing, and Camp Downes Bridge.

SECTION 3.- No Cochero shall be allowed to load more than four (4) passengers or shall refuse to conduct any passenger to his place or destination, except for the following causes:

- (a)- The tartanilla has been rendered unsafe for further travel.
- (b)- The horse has become too tired for further service and the tartanilla is actually bound hom.

SECTION 4.- Every Cochero shall post in a conspicuous place in the tartanilla a copy of the schedule of rate or tariff set forth in Section 1 hereof.

SECTION 5.- Any person or entity whether an association or corporation found violating, directly or indirectly, the provision or provisions of this ordinance shall be punished by a fine of not more than ₱200.00 or by an imprisonment of not more than six (6) months or both such find and imprisonment at the discretion of the Court.

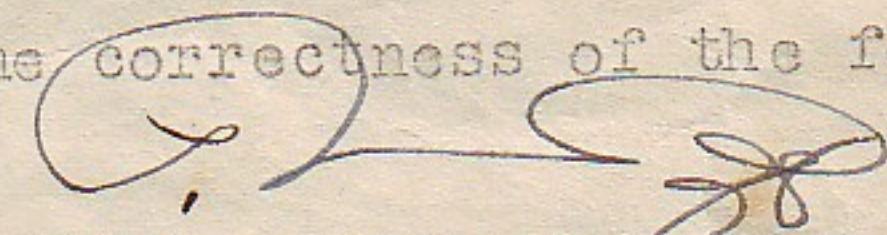
SECTION 6.- All previous ordinances or portions thereof in conflict with this ordinance are hereby repealed.

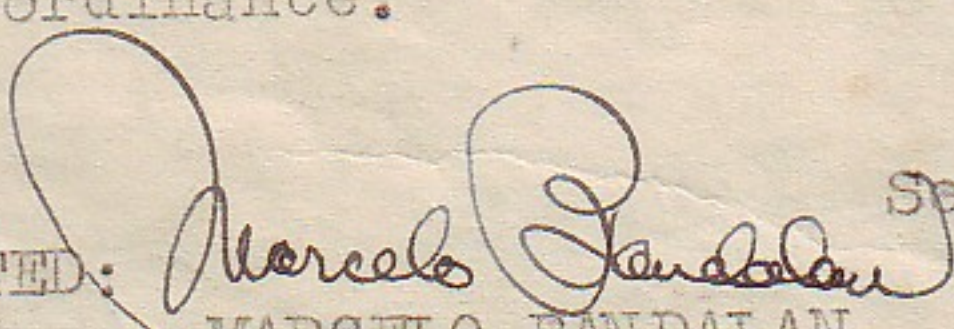
SECTION 7.- This ordinance shall take effect immediately upon its approval.
