RESOLUTION NO. 256

The letter of Mr. T. Pardo de Tavera, Acting Director,
National Bureau of Investigation, Manila, dated September
15, 1948 was read and submitted for the consideration of
the Board.

The Board, on motion of Councilor Omega, seconded by
Councilor Montesclaros, enacted the Appropriation Ordinance
as follows:

ORDINANCE NO. 19

AN ORDINANCE APPROPRIATING THE SUM OF P600.00 TO BE
MADE AVAILABLE FOR THE EXPENSES OF TWO PENSIONADOS
POLICE OFFICERS TO BE SENT TO THE NATIONAL BUREAU OF
INVESTIGATION, MANILA.

Be It Ordained by the Municipal Board of Ormoc City,
that;

SECTION 1.-Resolved, That the City of Ormoc should send
Two(2) Police Officers of the Police Department as pensiona-
dos to the National Bureau of Investigation, Manila, to be
trained for a course of instruction for such police officers.

SECTION 2.-Resolved Further, That the amount of Six
Hundred (P600.00) Pesos be reverted from Classification C-15-
(a) and appropriated for the expenses of the aforesaid police
pensionados incident to the school attendance, such as trans-
portation to and from home stations, lodgings and subsistence
in Manila during the course of instruction for a period of
two months, beginning October 15, 1948.

SECTION 3.-Resolved Furthermore, That the Chief of Police
is hereby requested to select on a competitive basis the two
police officers from among the police officers of the Police
Department and submit their names to the Honorable City Mayor
for consideration and nomination, and

SECTION 4.-Finally Resolved, That the City Treasurer, Or-
(Over)

Ormoc City is hereby authorized, to prepare and submit a Supplemental Budget for this purpose, to the Board for consideration and approval.

SECTION 5.-This Ordinance shall take effect upon its approval.
