RESOLUTION NO. 266

The letter of recommendation of the City Fiscal, Ormoc City, dated October 5, this year, was presented for the consideration of the Board.

The Board, on motion of Councilor Pajaron, seconded by Councilor Montesclaros, adopted an Ordinance as follows:

ORDINANCE NO. 21

AN ORDINANCE TRANSFERRING THE SALARY OF MR. ISAIAS CAZAR TO DELFIN QUIETA, BOTH CLERKS IN THE OFFICE OF THE CITY ATTORNEY, ORMOC CITY, AND REVERTING THE FORMER SALARY OF MR. QUIETA FOR THE PURCHASE OF LEGAL BOOKS OF SAID OFFICE.

Be It Ordained by the Municipal Board of Ormoc City that:

Section 1.- The salary of Mr. Isaias Cazar, Clerk of the Register of Deeds, Office of the City Attorney, at P960.00 per annum, is hereby transferred and appropriated for the salary of Mr. Delfin Quieta, a clerk of the City Fiscal, Ormoc City, effective as of October 1st, 1948, in view of the fact, that the salary of said Mr. Cazar, is now taken from the National Fund, beginning October 1, 1948 as per communication of the City Attorney, dated October 5, current year, to the Honorable Municipal Board of Ormoc City.

Section 2.- That the former salary of Mr. Delfin Quieta, at P720.00 per annum, is hereby reverted and appropriated for the purchase of legal books, for the combined Library of the Municipal Judge and the City Fiscal, Ormoc City.

Section 3.- That the City Treasurer and the City Auditor, Ormoc City, be furnished each a copy of this Ordinance for their information and guidance.
