RESOLUTION NO. 279

The Board, on motion of Honorable Councilor Teleron,
seconded by Honorable Councilor Evangelista, adopted an
Appropriation Ordinance, as follows:

ORDINANCE NO. 24

AN ORDINANCE APPROPRIATING THE SUM OF SIX THOUSAND
TWO HUNDRED PESOS (P6,200.00) FOR THE CONSTRUCTION OF
QUONSET HUT AND FOR THE SUBSISTENCE OF THE CITY PRI-
SONERS, OUT OF THE SEVEN THOUSAND PESOS (P7,000.00) AP-
PROPRIATED UNDER CLASSIFICATION C-53 ORMOC CITY.

Be It Ordained by the Municipal Board, of Ormoc City,
that;

Section 1.--The sum of Six Thousand Two Hundred Pesos
(P6,200.00) out of the Seven Thousand Pesos (P7,000.00) ap-
propriated under Classification C-53, Transfer to School
Fund, be reverted and appropriated as follows:

- (a) Two Thousand Two Hundred Pesos (P2,200.00)
for the construction of Quonset Hut, C-61; and
- (b) Four Thousand Pesos (P4,000.00) for the sub-
sistence of the City Prisoners, C-22-g.

Section 2.--That copies of this resolution and Ordi-
nance be furnished the Honorable City Mayor, the City Treas-
urer, the City Auditor and the Chief of Police, Ormoc City,
for their information and guidance.

CARRIED UNANIMOUSLY.

Honorable Councilor Omega voted yes, with the assu-
rance of the City Treasurer that the City School does not
need this fund any more.
