RESOLUTION NO. 281

The Board, on motion of Councilor Evangelista, seconded by Councilor Montesclaros, adopted an Ordinance, to wit;

ORDINANCE NO. 25

AN ORDINANCE CREATING THE POSITION OF A WHARFINGER
AND THE INSTALLATION OF SEVEN MORE ELECTRIC BULBS
AT ORMOC PIER, THIS CITY.

Be It Ordained by the Municipal Board of Ormoc City
that;

Section 1.-The position of a Wharfinger is hereby created to take charge of Ormoc Pier, at a rate of Three Pesos(7.00) a day.

Section 2.-That seven(7) more electric bulbs be installed at Ormoc Pier, (2 bulbs of 50 watts and 5 bulbs of 25 watts)

Section 3.-That copies of this resolution and Ordinance be furnished the Honorable City Mayor, the City Treasurer, the City Auditor and the Manager, Ormoc Electric Light Company, Ormoc City, for their information and guidance.

Section 4.-That this Ordinance shall take effect immediately upon its approval.
