RESOLUTION NO. 284

The Board, on motion of Honorable Councilor Teleron, seconded by Honorable Councilor Evangelista, adopted an appropriation Ordinance, to wit;

ORDINANCE NO. 26

AN ORDINANCE AMENDING ORDINANCE NO. 24, UNDER RESOLUTION NO. 279, CURRENT SERIES, TO INCLUDE AN APPROPRIATION OF SEVEN HUNDRED (P700.00) PESOS OUT OF THE SEVEN THOUSAND (P7,000.00) PESOS APPROPRIATED UNDER CLASSIFICATION C-53, FOR THE PURCHASE OF TWO HECTARES OF LAND AND FOR ITS SURVEY SITUATED IN BARRIO SAN JOSE, ORMOC CITY.

Be It Ordained by the Municipal Board, of Ormoc City, that;

Section.- Section 1 of Ordinance No. 24, under Resolution No. 279, current series, is hereby amended, so as to include the sum of Seven Hundred (P700.00) Pesos out of the Seven Thousand (P7,000.00) Pesos appropriated under Classification C-53, Transfer to School Fund, be reverted and appropriated, as follows:

- (a) Six Hundred (P600.00) Pesos for the purchase of Two (2) hectares of land Lots Nos. 7030 and 8574, owned by the Heirs of Angel Pardo, for the additional school site of San Jose Elementary School, Ormoc City, C-60, and
(b) One Hundred (P100.00) Pesos for the resurvey of subdivision of the additional school site of San Jose Elementary School Ormoc City,

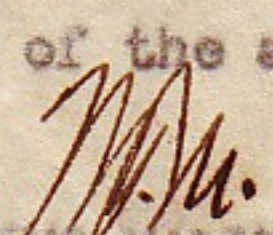
