ORDINANCE NO. 27

AN ORDINANCE APPROPRIATING THE SUM OF ONE THOUSAND SIX HUNDRED  
EIGHTY (\$1,680) PESOS FOR THE CONTINGENT EXPENSES AND ADDITIONAL  
EMPLOYEE IN THE OFFICE OF THE CITY MAYOR AND FOR THE DIFFERENCE  
IN SALARY OF THE BOARD MESSENGER-JANITOR  
ORMOC CITY

Be It Ordained by the Municipal Board of Ormoc City, that:

Section 1.- The creation of one correspondence clerk and the miscellaneous expenses as requested in the above quoted basic letter of the City Mayor is hereby approved, to take effect on January 1st, 1949.

Section 2.-The appropriation for the difference in salary for the position of one Janitor-Messenger in the amount of P240.00 from July 1, 1948 to June 30, 1949, Office of the Municipal Board, in accordance with the approved appointment of said Janitor-Messenger by the Honorable Undersecretary of the Interior, Manila, is hereby approved.

Section 3.- The sum of One Thousand Six Hundred Eighty(P1,680.00) Pesos is hereby appropriated to cover the salary, Expenses and difference in salary as embodied in Sections 1 and 2, of this Ordinance.

Section 4.- The City Treasurer, Ormoc City is authorized to make a Supplemental Budget to cover the sum of One Thousand Six Hundred Eighty(P1,680.00) for the purposes as mentioned in Section 3 of this Ordinance.

Section 5.-That copies of this resolution and Ordinance be furnished the Honorable City Mayor, the City Treasurer and the City Auditor, Ormoc City for their information and guidance.
