Be It Resolved, to adopt;

ORDINANCE NO. 28

AN ORDINANCE AMENDING LETTER(a) UNDER SECTION 1,
OF ORDINANCE NO. 24, UNDER RESOLUTION NO. 279, CURRENT
SERIES, OF THE MUNICIPAL BOARD, ORMOC CITY.

Be It Ordained by the Municipal Board of Ormoc
City and by authority of the same, that;

Section 1.-Letter (a) under Section 1, of Ordinance
No. 24 under Resolution No. 279, current series,
of the Municipal Board of Ormoc City, is hereby amended,
to read as follows:

(a) Two Thousand Nine Hundred (P2,900.00)
Pesos be appropriated for the construction of the Quon-
set Hut, C-61; and

(a) One Thousand One Hundred (P1,100.00)
Pesos be appropriated for the improvement and filling of
the government owned lot whereon the quonset hut will
be constructed.

Section 2.-The City Treasurer is authorized, as
he is hereby authorized, to take the necessary appro-
priation for this purpose from the over collections of
all items not otherwise appropriated, and to make the
necessary adjustment or amendment of the Supplemental
Budget already made by said Treasurer per Ordinance No.
24, under Resolution No. 279, current series, in order
to meet or carry out the purpose of letters(a) and (a-1),
under Section 1 of this Ordinance.

Engineer, the Honorable City Mayor and the City Auditor, Ormoc City, for their information and guidance.

Section 4.- That this Ordinance shall take effect immediately upon its approval.
