ORDINANCE NO. 30

AN ORDINANCE CREATING THE POSITION OF THE ASSISTANT CHIEF OF POLICE, ORMOC CITY, WITH COMPENSATION OF ONE THOUSAND EIGHT HUNDRED (₱1,800.00) PESOS PER ANNUM.

Be It Ordained by the Municipal Board of Ormoc City and by authority of the same, that;

Section 1.-The position of the Assistant Chief of Police, of Ormoc City is hereby created with the compensation of ₱1,800.00 per annum.

Section 2.-That the aforesaid Assistant Chief of Police should take direct supervision of the Secret Service Force, under the Police Department, Ormoc City.

Section 3.-The City Treasurer of Ormoc City is authorized, as he is hereby authorized, to make the necessary appropriation to be taken from the over collections of the City funds and from any available source not otherwise appropriated and to make a Supplemental Budget for this purpose.

Section 4.-That copies of this resolution and Ordinance be sent to the Honorable Secretary of the Interior, the Honorable Secretary of Finance, Manila, requesting for their approval, and to the Honorable Jose Avelino, Senate President; Honorable Carlos S. Tan Senator-at-large; Honorable Domingo Veloso, Congressman for the 2nd district of Leyte and to the Honorable Jose Martinez, Congressman for the 1st district of Leyte, for their information and favorable recommendation.
