BE IT RESOLVED, as is hereby resolved to adopt;

ORDINANCE NO. 4

AN ORDINANCE AMENDING SECTION 17, ORDINANCE NO. 6  
SERIES OF 1948

BE IT ORDAINED, by the Municipal Board this City that;

SECTION 1.-Henceforth, Section 17, paragraph I, of  
Ordinance No. 6 series of 1948 which imposes a charge or fees  
of ₱3.00 to every private persons, company or corporations  
who has installed or shall hereafter may install fire hydrant  
such fees or charges is hereby abolish.

SECTION 2.-That fire hydrant so installed in private  
companies or corporations at the expense of interested parties  
or parties, shall be under the direct supervision of the  
waterworks.


SECTION 3.-That in case of emergency, the fire plug  
or hydrant aforesaid shall be under the supervision of the  
Fire Department.

SECTION 4.-Penalty: Any person firm or corporations  
found violating the provisions of this ordinance such  
fine and penalty provided for in Section 27 of Ordinance  
No. 6 as herein amended shall be imposed.
