RESOLUTION NO. 186

The Board, on motion of Vice Mayor, Marcelo D. Bandalan,
seconded by Councilor Porfirio Ayuyao,

RESOLVED, as is hereby resolved to adopt;

ORDINANCE NO. 6

AN ORDINANCE AMENDING SECTION 3, SUB-SECTION "c" OF
ORDINANCE NO. 10 SERIES OF 1948 BY ADDING SUB-SECTION
"d" AND "e" ON SAID SUB-SECTION "c".

Be it Ordained by the Municipal Board, this City that;

SECTION 1.-Section 3 of sub-section "c" of Ordinance
No. 10, series of 1948, is hereby amended by adding Sec-
tions "d" and "e" so as to read as follows:

(1) Hereafter, all TPU trucks going north or north-
west and going south, besides parking on the streets de-
signated in Section 3, sub-sections "a" and "b" of Ordin-
ance No. 10, the same are also allowed to park along
Bonifacio St. up to the Lighthouse only and along C. Aviles
St., Burgos St. and Rizal Sts. Said TPU are hereby barred
to enter at the pier, either to pick up passengers or to
load and unload cargoes. This modifying sub-section "c"
of said Ordinance No. 10 emphasizing the lighthouse as
the limit.

(e) Vehicles mentioned below are allowed to enter
the pier to the exclusion of others, as follows:

1. Auto Galesas 2. T-Trucks 3. TH-Trucks
4. Owner 5. Gov't Cars 6. Animal Drawn Vehicles

Provided however, that all vehicles hereby allowed
to enter at Ormoc Pier from the lighthouse, as above
enumerated, should not park at the pier longer than the
time required for loading and unloading cargoes and pas-
sengers, to avoid congestion of traffic vehicles at
Ormoc pier.

SECTION 2.-Penalties: Any person firm or corporation found violating any provisions of this ordinance shall suffer such fine and penalties as provided for in Section 4 of Ordinance No. 10.

SECTION 3.-Repeal: All other provisions of any ordinance inconsistent with the provisions of this Ordinance is hereby repealed.

SECTION 4.-Effectivity: This Ordinance shall take effect upon its approval.


