RESOLUTION NO. 187

The Board, on motion of Vice Mayor, Marcelo D. Bandalan,
seconded by Councilor Porfirio Ayuyao,

RESOLVED, to adopt;

ORDINANCE NO. 7

AN ORDINANCE AMENDING SECTION 4, SUB-SECTION 1 OF
ORDINANCE NO. 1 SERIES OF 1950 AND FURTHER AMENDING
SECTION 6 OF SAID ORDINANCE.

Be it Ordained by the Municipal Board this City that;

SECTION 1.-Instead of 300 lineal meters distance
from one gasoline station to another as provided for
in Section 4, of sub-section 1 of Ordinance No. 1 series
of 1950, the same is amended to disregard distance by
lineal meter but from corner to corner.

SECTION 2.-Fees. An inspection fee of P50.00 is charge
to every newly constructed gasoline station, instead of
P20.00 thus further amending Section 6 of Ordinance No. 1,
series of 1950.

SECTION 3.-Penalty. Penalties provided for in Ordinance
No. 1 series of 1950 for person found violating the provisions
of this Ordinance, such fine and imprisonment as provided in
the aforementioned Ordinance is hereby imposed.

SECTION 4.-Effectivity: This Ordinance shall take effect
upon its approval.
